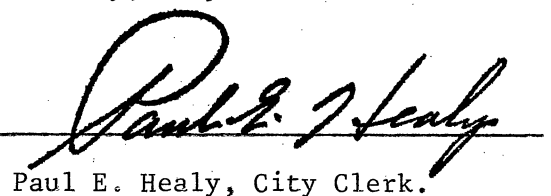

- WHEREAS: This City Council by order adopted March 11, 1985 has requested the City Manager to begin preparation of the application in concert with the Cambridge Transportation Forum and the Cambridge Historical Commission, to prepare the necessary documentation and application for consideration of the MBTA's Station Name Review Committee prior to the March 28, 1985 deadline indicated in correspondence from the MBTA dated February 27, 1985; therefore be it
