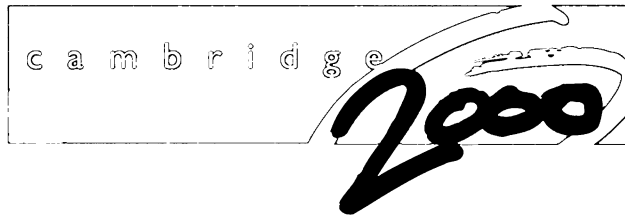

I am hereby requesting the appropriation \$30,415 from the U.S. Department of Housing through the Cambridge Housing Authority to the Grant Fund Human Services Salaries and Wages account (\$26,551) and Other Ordinary Maintenance account (\$3,864) to provide funds to enable the Community Learning Center's Bridge Program to provide classes to CHA residents.
