I am hereby requesting the appropriation of \$158,400.00 in the Grant Fund of the Department of Human Services Salaries and Wages Account (\$103,611.00), the Other Ordinary Maintenance Account (\$53,989.00) and the Travel and Training Account (\$800.00) from the Massachusetts Executive Office of Communities and Development.
