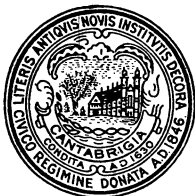


Dear Sir:

I hereby request an appropriation in the amount of \$333.99 to reimburse Frank P. Wright, an employee of the Public Works Department for damages in this amount.

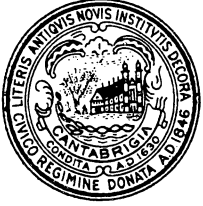
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Frank P. Wright in which there was a judgment of \$333.99.


