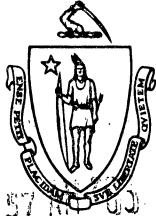

STATEMENT OF REASONS

The State Ballot Law Commission hereby grants the Motion to Dismiss filed by the respondents on August 2, 1983 for the reasons stated in that Motion. Specifically, the Commission finds that it does not have jurisdiction to consider challenges to the manner and procedure by which the Cambridge Election Commission reviewed the signatures submitted on the local initiative petitions as contained in Parts, IIA, IIB and IIC of the Objection.

Further, the Commission finds that the legal objections contained in Parts IID(4), IID(5), IID(6) and IID(8) are without merit, as the names of the signers can be reasonably determined to be those of registered voters.

Accordingly, the Motion To Dismiss is allowed.

Chairman Tisdale and Commissioner Mejan dissent.



OBJECTION

Gertrude Cunniff, of 9 Vail Court, Cambridge, Caryl L. Graham, 375A Harvard Street, Cambridge, and Roger E. Mascoll, of 25 Copley Street, Cambridge, all registered voters of the City of Cambridge, hereby make written objection, pursuant to Mass. Gen. Laws c.43, §38, to the certification by the Cambridge Election Commission on July 26, 1983 of 4,570 signatures in support of a city initiative petition.

STATEMENT OF FACTS

Signatures of Cambridge voters have been gathered in support of a local initiative petition which would enact a provision entitled The Nuclear Free Cambridge Act. On or about July 18, the proponents of the initiative petition filed with the Cambridge Election Commission 223 petition sheets on which were recorded approximately 5800 signatures.

Mass. Gen. Laws c.43, §40, provides in pertinent part:

Section 40. Proceedings if Petition Not Fully Signed.

If an initiative petition is signed by registered voters equal in number to at least eight percent but less than fifteen per cent of the total number of registered voters, and said measure be not passed without alteration within twenty days by the city council... such proposed measure, without alteration, shall be submitted by the city council to a vote of the registered voters of the city at the next regular municipal election...

The Cambridge Election Commission determined that even if all 5800 signatures filed were valid signatures of registered voters of Cambridge, those signatures represented less than 15% of the registered voters of Cambridge. Accordingly, the "equal in number to at least eight per cent but less than fifteen per cent of the total number of registered voters" language of §40 would apply. The Cambridge Election Commission then determined that 8% of the registered voters of Cambridge would be 3,281 registered voters. The Election Commission then decided that it would review the initiative petitions until it had certified 140% of the number required, which according to the Election Commission's calculation would be 4,593 voters. Ultimately, the Cambridge Election Commission certified 4,570 signatures as being those of registered voters of Cambridge, and on July 26, 1983 the Election Commission presented this certification to the City Council, as required by G.L.c.43, §38.

Ms. Cunniff, Ms. Graham, and Mr. Mascoll (hereinafter "the objectors"), hereby file their written objection to this certifi-

cation with the City Council and with the Election Commission, in compliance with the provisions of G.L.c.43, §38. The objectors are also filing a copy of this objection with the State Ballot Law Commission. According to G.L.c.43, §38, the City Council is required to forward this objection to the Ballot Law Commission, and that Commission is then required to hold a public hearing on the objection, and to render a decision on the matter within 14 days after the objection is filed.

## OBJECTIONS TO THE ELECTION COMMISSION'S

### CERTIFICATION OF SIGNATURES

#### I. Introduction

The objectors have four basic categories of objections to the certification of signatures, each of which renders the Cambridge Election Commission's certification invalid. As a result of both the use of impermissible procedures and the commission of numerous particular errors in declaring signatures valid, there has been no valid certification of the 3280 registered voters needed to place the initiative before the City Council or on the ballot under G.L.c.43. Three of the objections are to the method of certifying signatures, which was done by the Election Commission in a manner which made critical errors inevitable. The fourth set of objections is of the more traditional variety; as set out in detail below, hundreds of the particular signatures certified as valid should have been rejected as invalid, but were not. This memorandum will address each of these objections in turn.

## II. Objections

The initiative petition process is a form of the electoral process. By the initiative petition procedure, private citizens attempt to enact legislation by placing matters on the ballot which their elected representatives, for whatever reason, have not seen fit to consider. Here, the Cambridge City Council has not chosen to enact the initiative measure proposed by the petitioners; the City Council has not chosen to determine the country's foreign policy or defense policy, as the petitioners seek to do.

The initiative petition is only to be placed on the ballot, pursuant to Mass. Gen. Laws c.43, §§37 et seq., if 8% of the registered voters of the city favor it. Especially since the petitioners propose to place on the ballot a measure of wide and serious ramifications, certification of the signatures should be treated with the same degree of seriousness as voting at a polling place is treated on an election day. Yet in several key ways that contrast vividly with procedures for identifying registered voters at an election, the Election Commission adopted procedures which inevitably result in certifying many invalid signatures.

- A. The Cambridge Election Commission Failed to Exclude Voters Registered in 1982 But No Longer Registered in 1983.

The Cambridge Election Commission began its review by comparing the signatures on the petitions submitted to its own 1982 voting list. If a name appearing on a petition was not found on

the 1982 voting list, the Election Commission then looked for that particular signature on a variety of supplemental lists. Then, near the end of the Commission's review of signatures, the 1983 voting list apparently became available. This new voting list contains all the persons currently registered to vote in the City of Cambridge -- and hence eligible to sign the petition. It does not include the many persons who were on the 1982 voting lists but who have subsequently moved out of Cambridge.

(Cambridge conducts a census early every year to determine the current residence of its voters and for other purposes. Therefore, if a person were registered on the 1982 list, then moved out of Cambridge, that person would not be present in Cambridge to complete the 1983 census, and would then be removed from the 1983 list. This is a very effective means of keeping the voting list current in a city with the high transiency rate of Cambridge).

The Election Commission used the 1983 voting list to attempt to validate signatures which they had not been able to find on the 1982 voting list. They did not, however, use the new current list to eliminate names they had previously validated by using the 1982 list -- names of persons who were voters in Cambridge a year ago who are no longer registered to vote there. Under this arbitrary method of using the current list of registered voters to validate signatures, the proponents of the initiative have it both ways: People who have left Cambridge and are not now registered voters are still counted because the 1982 list was first used; people who have recently moved to Cambridge and registered

to vote, thus appearing on the 1983 list, are also counted.

Thus, in counting the old voters who are no longer registered, the Election Commission counted large numbers of people who are not registered to vote in Cambridge. This error is especially egregious because the Election Commission proceeded asymmetrically, using the new list to include new residents (indeed this was perfectly proper) at the same time as it used the old, out-of-date list to include signatures which are no longer valid.

As an inevitable result, a large number of persons who signed the petition, who were registered to vote in 1982 but are no longer registered voters of Cambridge, were improperly included. For example, a person who has lived in Wellesley since mid-1982 could have signed the petition with his or her former Cambridge address and be counted, though that person is not now a registered voter and would not be allowed to vote today at his or her former polling place in Cambridge. Appendix 1, attached hereto, gives some examples of persons who signed the petition, who were counted by the Election Commission as valid registered voters because they appeared on the 1982 list, but who are no longer registered voters according to the 1983 list. (The objectors' examples in Appendix A are taken from a check of the two petitions from Ward 6, Precinct 3, because that area contains a large number of Harvard University dormitories where a high transiency rate can be expected. The Harvard upper class dormi-

tories contain students in their sophomore, junior, and senior years. Thus one could anticipate that 1/3 of the students of the students registered in a particular dormitory would no longer be registered there the following year. The transiency rate in various other sections of Cambridge is probably not much less than this 1/3 rate in the Harvard dormitories.)

The objectors have not tallied all such persons improperly counted. Nor were they able to do so, since they had extremely limited access to the 1983 voting list. In any case, it is the role of the Election Commission, not the role of private parties, to ensure that only the signatures of currently registered voters of Cambridge were counted.

The Cambridge Election Commission's method of validating signatures has allowed as valid the signature of any person who has been registered in Cambridge at any time in the last two years. Thus, the Election Commission's procedure was inherently flawed by its failure to check all signatures against the current, 1983 voting list. The result was, necessarily, that invalid signatures were counted. The Election Commission's certification must be rejected on this basis; at a minimum, an accurate recount, based entirely on the proper, current voter list is necessary.

B. The Cambridge Election Commission failed to check  
Against Duplications

Secondly, the Election Commission wholly failed to check for duplications. The Election Commission had several persons each reviewing a stack of initiative petitions submitted by the

petitioners. Unlike the procedure at an election, when the Commission checked the validity of a signature, it did not record on its master list that that voter had been counted. Unless an examiner of the Election Commission happened to see and remember that he or she had earlier seen the same signature, anyone could be counted two, three or 17 times, by signing different petition sheets (or indeed perhaps by signing the same sheet twice). This is not an idle worry. Certainly many people have strong views on nuclear disarmament issues, and would be quite eager to sign petitions on repeated occasions -- which they might not recall or understand to be the same as one they previously signed. The objectors have discovered several duplications completely by happenstance, while reviewing each name for consistency with the voter registration list. A list of examples of duplications is attached as Appendix 2.

The objectors had no master list against which they were checking the signatures, and were unable to tally all such duplications. Nor is that their function as private concerned citizens; it is the function of the Cambridge Election Commission, which responsibility was completely ignored. Given the likely zealotry of proponents of the petition as well as the normal vagaries of the process of gathering signatures at many times and places on the city streets, it is likely that there were numerous duplications. The point is, again, that the City Council and the Ballot Law Commission cannot tell how many -- and hence cannot tell if the required 3281 registered voters signed --

because the Election Commission didn't check properly. The current certification must be rejected as invalid on this basis; at the least, a proper, accurate recount is necessary.

C. The Cambridge Election Commission Did Not Compare Signatures on the Petitions with Signature Cards

The Cambridge Election Commission in its review of the petitions compared the signatures on the petitions only with the names on the voter list which appear in a typed, computerized form. There was no effort whatsoever to compare signatures with those on the voters' signature cards to determine whether the person signing the name on the petition was that in fact the voter. It is well established that one ground for challenge of signatures is on the basis of fraud or forgery. However, the Cambridge Election Commission's methods provide no means to determine whether such fraud or forgery has occurred. One simply had to sign the name of someone known to be a Cambridge resident for that name to be counted by the Election Commission. The objectors themselves, strong opponents of the initiative petition, could have had their names signed by someone else, and their signatures would still be counted under the Election Commission's methods. This too is not an idle concern; certainly a number of people in Cambridge and in other areas in the Commonwealth are very concerned about the issues involved in this initiative petition. If a resident of another municipality were accosted by someone seeking signatures for the petition, he might decide to sign the name of a friend who was a Cambridge resident so that the signature would "count".

The comparison of signature against signature becomes even more critical in the large number of signatures on the petition which are illegible. One does not know whether they are illegible because that is how that person always signs his or her signature, or whether they were signed illegibly by someone who hoped that listing a proper address -- a building existing in Cambridge -- is itself enough, because the signature would be counted by the Election Commission even though it is impossible to read. As a specific objection in Section D, below, shows, such wholly illegible signatures were in fact counted on just this basis.

Unless the Election Commission compares signatures on the petitions to signatures on signature cards, as opposed to a typed, computerized voting list, there is absolutely no way in which a private citizen could ever determine whether any fraud or forgery had in fact occurred. Under the Election Commission's procedure, a zealot eager to get a petition on the ballot could simply obtain a voting list, which is a matter of public record, and copy signatures off that list. Such action would clearly constitute fraud and forgery, but would remain wholly undetected under the methods used by the Cambridge Election Commission. Again, no quantification as to the number of possible errors which could have occurred under the Cambridge Election Commission's current methods can be given.

The failure to compare signatures on the petition to signature cards on file of the Election Commission is not an idle or

trivial oversight. In their review of the signatures, the objectors discovered several instances in which one person had signed two different names on the petition. Thus, for example, on Petition #30, it appears that one person signed the names Adrienne P. Hart and Adrienne P. Steele, 101 Fayerweather Street, Ward 9, Precinct 2. As another example, on Petition #202, it appears that the same person signed the names Gweneth Knight and Richard Knight, both of 149 Brattle Street, Ward 8, Precinct 1. The Election Commission certified both signatures, with identical handwriting, as valid. Given the failure to compare signature against signature, one can only surmise how many persons may have signed not only their own name, but that of their friends as well, in their enthusiasm for the petition.

In addition, the objectors saw repeated instances in which a last name or full name was printed in parenthesis next to an illegible signature. Examples of these instances are collected in Appendix 3, attached hereto, which does not purport to be exhaustive. In many instances, the printed names all appeared to be in the same ink and of the same handwriting for an entire petition: obviously, the person collecting signatures rather than the individuals signing their names to the petition was responsible for these parenthetical identifications. In most instances in which the printed name was provided, it would otherwise be impossible to decipher the signature appearing on the petition. One has no way of knowing at what time during the collection of signatures such parenthetical additions were made.

One might hope, of course, that the person collecting signatures had simply asked a person signing the petition with an illegible signature to print his or her name beside the signature. This does not appear to be the case, however, when all the illegible signatures on a page of a petition are accompanied by explanatory printing in the same handwriting. While one would hope that the petitioners did not later supplement their petition by consultation with a voting list in order to obtain a greater number of certifiable names (although the Election Commission provided the petitioners with a voting list at their request several weeks prior to the petitioners' submission of the signatures to the Election Commission for certification), one cannot assume the contrary, either. As a result, names accompanied by such printing are suspect.

For these reasons, the failure even to check signatures renders the entire certification powers invalid.

D. Specific Objections to Signatures on Petitions

In addition to the three procedural defects discussed above, the objectors uncovered considerable numbers of individual signatures which should be rejected for a variety of reasons.

1. Signatures by Persons Not Registered to Vote. The first, and the most obvious, category of signatures are those of persons who are simply not registered to vote at the address they gave on the petition. These signatures have been collected in Appendix 4, attached hereto. Again, because it is not the objectors' responsibility, but rather the responsibility of the

Election Commission, Appendix 4 is not an exhaustive list. On the other hand, it does provide at least an indication of the magnitude of the problem. These signatures were improperly counted.

2. Illegible Signatures. A second, larger group of persons produced signatures so illegible that one has no idea whether or not they might be a person registered at the address given. These signatures are gathered in Appendix 5, attached hereto. The objectors have already addressed at length their particular concern as to illegible signatures which contained a parenthetical printed name in hopes of legitimating an unreadable signature. An even larger group of signatures were not so assisted, and therefore simply remain illegible. It appears that in its certification, the Election Commission was overly generous; once having determined that the address provided was the address of some registered Cambridge voter, the Election Commission apparently assumed that at least one of them must have signed the petition. Such leaps of faith are not appropriate, given the seriousness and the formality of the initiative petition process.

In Appendix 5, the objectors have identified the signatures they believe to be truly illegible. In many instances, the objectors have provided the number of registered voters at the address written on the petition, to give an indication of the consequences of the inability to identify the signature. Thus for example, on petition #84, there are 32 registered voters

residing at 872 Massachusetts Avenue. At 16 Pine Street, there are five people named Rose (see petition 87.) It is not the role of the Election Commission to make assumptions that the person signing the petition must be one of those many voters; rather, it is likely that in a large apartment building that a considerable number of persons reside who are not registered to vote in Cambridge. For these reasons, the illegible signatures should not have been counted.

3. First Name Differs. Another frequent error appearing on the petitions is the certification of signatures when the last name and address are those of a registered voter or voters in Cambridge, but the first name is not. Thus for example on petition #81, Pete Weiler of 92 Wendell Street, Ward 7, Precinct 2, signed the initiative petition, whereas the only Weiler appearing on the voting list is Kathleen A. Weiler of the same address. The signature was allowed, perhaps reflecting a decision that Kathleen and Pete are the same person. Similarly on petition #233, Chris Cousins of 9 Newton Street, Ward 5, Precinct 3, signed the initiative petition whereas Carla Cousins and Hoyt Cousins are the only two persons of that last name registered at that address. Further examples of such instances are collected in Appendix 6, attached hereto. Again, the Election Commission thought it sufficient if some of the pieces matched. But that is totally improper; otherwise one registered voter could make an entire household eligible to vote. If Kathleen Weiler chooses to be a registered voter in Cambridge

and Pete Weiler does not, Kathleen Weiler can enjoy the privileges of such status; but Pete Weiler's signature can no more be counted on this initiative petition than he could vote at a Cambridge polling place without having registered. These signatures were improperly counted.

4. Failure to Add Suffixes. In many instances, the Election Commission certified signatures of persons who failed to provide the "Junior" or "Senior" or "III" reflected on the voting list. Plainly, this is not an idle concern, because the suffix "Junior" implies a father and the "III" may well imply a "Junior". Indeed, in several instances, both father and son are registered at the same address. Even if one or the other has not bothered to register to vote, the confusion is no less great. One cannot imply the presence of a "Junior" when it does not accompany the signature on the petition. Obviously, the Election Commission cannot make an inquiry in every case as to whether or not the father, the grandfather, the son, and so forth are or are not residing at a particular address. Instead, the Election Commission is limited to the face of the document itself, and on its face, it is not clear that a person signing, for example as Gordon Stryker, of 16 Russell (petition #2018, Ward 10, Precinct 1) is in fact Gordon C. Stryker or Gordon A. Stryker, Jr., both of whom are registered at the same address. Instances of signatures where the suffixes omitted were attached hereto as Appendix 7.

5. First Initials Only. Another common failing in many of the signatures is the lack of a first name. In many instances,

the person signing the petition simply provided a first initial and last name, rendering it difficult to determine whether that person is the registered voter shown on the voting list. The Election Commission apparently used its discretion and decided that if the last names matched and the first initial matched that of the first name of a registered voter, that was sufficient. Again, it is not the Election Commission's role to make such assumptions. In the example in Section 3, above, of Chris Cousins signing the petition while Carla Cousins was the voter registered, should Chris Cousins' signature become any more valid if he or she had signed C. Cousins instead? Why should the Election Commission assume that C. Cousins is in fact Carla Cousins, when there apparently is an unregistered C. Cousins at the same address? Examples of signatures bearing only first initials are attached hereto as Appendix 8. The casual or shorthand signatures shown in the Appendix should not be viewed as sufficient to identify a registered voter, given the strong likelihood of confusion with other, unregistered persons.

6. Nicknames. A related issue is that of nicknames. Many persons apparently treated the signing of this initiative petition as one would view signing up for a local bake sale. Nicknames such as "Suzy", "Vicki", "Bob", "Fred" and "Donny" abound throughout the petitions. Assuming one can ignore such casual treatment of the petition process, one can still not overlook those nicknames that raise a serious possibility of confusion. Again, to certify signatures with such nicknames, the

Election Commission must on its own make certain assumptions. While "Bob Slate" may easily be "Robert D. Slate" of 64 Linnaean Street, Ward 7, Precinct 5, (although Mr. Slate signed the petition at least twice, once as Bob Slate on petition #25 and once as Robert Slate on petition #2036), other nicknames require more imaginative interpretations, the Election Commission which constitutes an improper exercise of discretion. Thus, for example, on petition #252A, can one assume that Lucy Weiss of 988 Memorial Drive is the same person as Louise Weiss of that address? Perhaps Louise has a sister Lucy; should the Election Commission be allowed to decide? Similarly, is Mimi Storey of 62 Kirkland Street, Ward 6, Precinct 2, who signed petition #2079, the same person as Mary S. Storey? Is Berni Zisseron, of 65C Dana Street, #30, Ward 6, Precinct 1, who signed petition #2078 the same person as Bernadine Zisserman, a registered voter? Is Zuad Stephan of 2353 Massachusetts Avenue, Ward 11, Precinct 1, who signed petition #2025 the same person as Zouhair F. Stephan, a registered voter? Is Sally Swenson of 103 Norfolk Street, Ward 2, Precinct 1, who signed petition #2039, the same person as Solveig M. Swenson, or is Sally instead Solveig's wife, sister or other relation? The law does not allow the Election Commission to ponder these questions; it simply requires them to determine on its face whether the person who signed the initiative petition is registered to vote. Weakening of that standard to allow these signatures can only downgrade the initiative petition process.

7. Discrepancies in Last Names. In many instances the person signing the initiative petition has provided a different variant form of his or her last name (if indeed the person signing is the registered voter). For example, on petition #107, someone signed the name Claire Hutchinson Lavin, 57 Ellery Street, Ward 4, Precinct 5. At that address resides a registered voter by the name of Claire Hutchinson. Again, the Election Commission could speculate as to whether Ms. Hutchinson has recently married Mr. Lavin, whether Ms. Hutchinson has been married to Mr. Lavin for a while but decided only recently to assume his name, or whether Ms. Hutchinson simply likes to vary her last name. A more interesting example is presented by a Ms. Joanne P. Sunshower of 10 Bowdoin Street, Ward 7, Precinct 5, who signed petition #2014. There is a Joanne Pierron Jonas at that address and "Jonas" is helpfully printed in (next to "Sunshower"). One could again engage in speculation as to the difference for these names. Since the speculation will, of course, remain inconclusive, the Election Commission should continue to require that voters register using their legal name, and that they adhere to that name when signing documents of the importance of this petition. These signatures should be declared invalid.

8. Middle Initials, Middle Names and Lack thereof. Finally, the objectors protest the Election Commission's lack standards with regard to the presence or absence of middle names and middle initials. In countless instances, persons registered to vote using a middle name or middle initial, but signed the

petition without one. Once again, the Election Commission has allowed less than straight compliance in certifying names.

The Election Commission may well be relying, in this instance, on Mass. Gen. Laws c.53, § 7, which allows an election commission to ignore the presence or absence of middle names or middle initials. Chapter 53, § 7, however, is only applicable to nominating papers for candidates running for public office. The timetable for the filing of nominating papers, the place of filing, and many other factors all differ radically from the statutory scheme contained in G.L. c.43A, §§ 37, et seq., which governs local initiative petitions. Similarly, the c.53, § 7 standards for certification of signatures do not govern in the case of local initiatives. (Section 22A of c.53 incorporates c.53, § 7 by reference, and that § 22A applies to initiatives and referenda. Section 22A, however, applies only to statewide initiatives and statewide referenda. See §§ 22A, et. seq. Nowhere in c.43 does the local initiative process incorporate either c.53, § 7 or c.53, § 22A by reference.

The Legislature's failure to incorporate into Chapter 43 the looser standards of c.53, § 7 must be seen as intentional. The Legislature changed the standards in some areas, and not in others. There is well-established case law concerning local initiatives, which makes it clear that strict conformity of the signatures on the petition with the voting list is required. See, e.g., Sharpe v. Registrars of Voters of Northampton, 342 Mass. 620, 622-23 (1961) (holding that rejection of signa-

tures that did not precisely conform to the voting records was correct); Carpenter v. Registrars of Voters of Marlborough, 327 Mass. 183 (1951). In the absence of any statutory or judicial amendment of c.43, § 37, et seq., there is no reason to assume that the strict compliance required by Sharpe and Carpenter can be ignored. As Carpenter stated, and Sharpe reaffirmed, the names on the petition must conform exactly to the names on the voting lists. That rule must be applied here, and the signatures shown on Appendix 11, attached hereto, should be rejected.

The various problems which make invalid many of the signatures certified, set out in this Section D, require the elimination of enough signatures so that fewer than 328-1 valid signatures remain. Thus, even aside from the procedural errors which have infected the entire certification process, there has not been a proper certification of a sufficient number of signatures of registered voters to place the initiative on the ballot.

For the reasons given above, the certification by the Cambridge Election Commission was invalid and unlawful, and the initiative at issue cannot be placed on the ballot.

3. This name is also listed on Appendix 8 because only an initial is given for the first name, making it difficult to be certain whether the signer was a registered voter.
4. This name is also listed on Appendix 11 as illegible; the name listed here is the objectors' best guess.
5. These names are also listed in Appendix 3 because someone printed the name "David H. Smith" after what appears to be "Paul H. Smith". In any event, neither name is registered at the address shown.
