I am hereby requesting an appropriation of \$147,000.00 in the Grant Fund of the Department of Human Services Programs' Planning and Development Divisions' Other Ordinary Maintenance Account from Office of the U.S. Department of Housing and Urban Development's Federal Emergency Shelter grant funds. Authorized under the Stewart B. McKinney Homeless Assistance Act, funds are awarded annually. The Department of Human Services contracts with local shelter providers for operating costs or rehabilitation costs of shelter facilities and for homeless prevention activities or essential services for the homeless.
