Directed multi-million expansion of electric, water, and sanitary sewer systems in coordination with Federal and State agencies. Directed planning and installation of first modular incineration facility in New England. Pioneered recycling of both organic and inorganic materials.

Instituted use of data processing equipment which has developed into present town-wide programs involving billing, appropriation accounting, inventory control, and many other adaptations utilizing third generation computer.

Active in coordination with Personnel Department in establishing continuous managerial programs in connection with Babson College; instrumental in development of first direct public works management courses. Supported continued education program for employees on all levels of work related subjects. Active in personnel management and labor relations dealing with both individual and group (union) problems, procedures, and policies.

Directed Electric Division studies, including plant inventory, distribution system present and future growth analysis; rate review and redesign, resulting in the adoption of a new flat rate structure, one of the first in the U.S. Specific system improvements resulted in the development of one of the most modern municipal electric utilities in the northeast. Participated in several years of rate hearings before Federal Power Commission.

Directed Water Utility studies, including present and future supply requirements; ground water availability, improvements to station equipment; leakage surveys; maintenance procedures. Instrumental in Town's decision to join Metropolitan District Commission.
