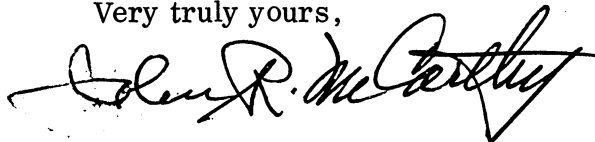

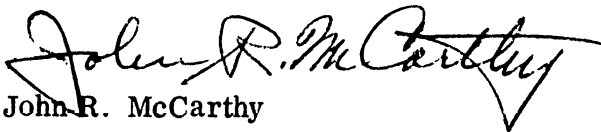

That no financial support for staff be provided to defray the costs of attending meetings, conferences, or conventions when such meetings, conferences, and/or conventions are held in those states that have not ratified the proposed amendment to the constitution of the United States prohibiting discrimination on the basis of sex; that staff members who belong to the associations which hold these conferences and conventions so inform their associations of the passage of this motion; further that the Secretary communicate with the Members of the City Council to amend the motion which they adopted on the E.R.A. urging them to change the effective date of their motion, and to boycott the League of Cities and Towns Convention in Las Vegas, Nevada.
