I am hereby requesting the appropriation of \$15,000.00 in the Grant Fund of the Department of Human Services Other Ordinary Maintenance Account from the Cambridge Public Health Commission. These funds will be combined with \$81,000.00 in the General Fund to enter into a contract with the Cambridge Economic Opportunity Committee for operation of the Food Pantry Network.
