I wish to speak before the Council regarding a complaint I filed with the Cambridge Internal Affairs Department on July 24, 1981. This complaint, to this day, has never been answered despite my constant efforts. *This hearing is requested for November 14, 1983 on the recommendation of Councillor Wylie*

I've worked on this problem for twenty-seven months now and feel that the Cambridge Police Dept., the Chief of Police, Mr. Healy, and Mayor Vellucci, purposely ignored me, knowing that I had medical records proving my damages. And that all I wanted and needed were the results of the investigation before pressing on.

As a citizen of Cambridge, I should have received the above information years ago. And as a citizen, I am disgusted and disgraced by the last minute trickery I received from Susan (The Council Secretary) on October 31, 1983.
