Dear Honorable City Council:

As a local coordinator for a group of 120 Youth Choir from the First Baptist Church in Dallas, Texas I request a permit to conduct an outdoor concert on Monday, July 29, 1996. The location at Harvard Square will be the corner of "Degugliama Plaza where many outdoor activities are taking place. We would like to hold the outdoor from 10 a.m. until 1:00 p.m. If it is a rainy day, then we will move to 1:00 - 4:00 p.m. on the following day, July 30, 1996.

We will have a truck to load/unload sound systems. Also, we may have 4-5 tour buses for choir members and their adult supervisors. While they are in town they will stay at Howard Johnson Hotel in Cambridge from July 21-August 2, 1996 (it's good for economy for this city).

On Monday, July 29 the group will be divided into two groups to perform the concert simultaneously. The other site will be at Kiosk known "The Pit" on Harvard T Station (it belongs to MBTA jurisdiction I will get the permit from them).

On July 30 & 31 we will have an approval from the First Baptist Church of Cambridge at Central Square (we used the church building for three years. Thus, we will have no problem to get their permission) from 10 a.m. till 1:00 p.m. We need the parking permit for those vehicles while we are holding the concert.

AS a local minister in Central Square area this young choir from Dallas to bring a positive impression to our residents in our city.

Please send copies of this letter to Community Development Service (Arts Council), Traffic Department, and The Work Department.
