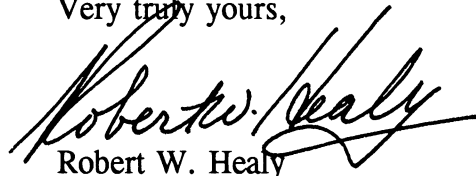

To The Honorable, The City Council:

I am hereby requesting two appropriation, the first appropriation of \$632,700.00 in the Public Investment Fund of Community Development Extraordinary Expenditure Account and the second appropriation of \$70,300.00 into the General Fund of the Community Development Salary and Wages Account (\$60,000.00), Other Ordinary Maintenance Account (\$9,800.00) and Travel and Training Account (\$500.00) from the U.S. Department of Housing and Urban Development. As a major element of the National Affordable Housing Act of 1990, the HOME Investment Partnership Act, i.e. the HOME Program, was established to provide financial assistance to help states and municipalities expand their supply of decent, safe and affordable housing. For the year 1996, the City has been allocated \$703,000.00 to be used for the rehabilitation and construction of affordable housing units. The expenditure of these funds will be administered by the Community Development Department which will base its selection of projects on the City's Consolidation Plan, approved annually by HUD. The affordable housing units to be developed may include acquisition, moderate rehabilitation, substantial rehabilitation, or construction for very low and low income families and for individuals who require social service support. Emphasis will be placed on rental units, especially for very low income families, although first time homebuyers will also be developed.
