Attached is an order requesting the appropriation of \$44,000.00 in the Grant Fund from the Massachusetts Department of Education to the Human Services Department Salary & Wages Account \$39,710.00, Other Ordinary Maintenance Account \$3,190.00 and Travel & Training Account \$1,100.00.
