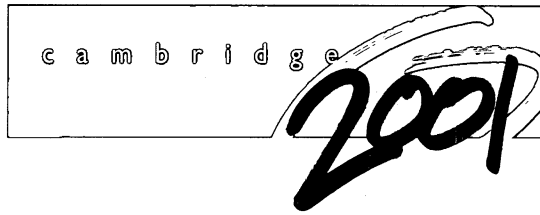

To The Honorable, The City Council:

I am hereby requesting the appropriation of a grant for \$205,435 from the Massachusetts Department of Education to the Human Services Grant Fund Salaries and Wages account (\$27,435) and Other Ordinary Maintenance account (\$178,000) to provide funds for nutritious meals to Cambridge youth at 33 sites throughout the City during summer months when schools are closed. 22 of these sites are enrolled camps with the remainder drop-in and open to anyone up to the age of nineteen. The Salaries and Wages funds will be used to cover a portion of the salary of the program director with the Other Ordinary Maintenance allotment covering the cost of food supplies as well as related program costs.
