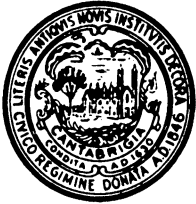

To The Honorable, The City Council:

Attached is an order requesting the appropriation of \$336,311.00 in the Grant Fund from the Executive Office of Communities & Development (EOCD) in additional funds for the Low Income Heating Assistance Program to the Human Services Salary & Wages Account \$17,678.00 and Other Ordinary Maintenance Account \$318,633.00. The additional funds will be used to assist approximately 4,000 low income clients in Cambridge and Somerville areas. The maximum benefit level for the past winter was \$520.00 per client. Clients must have a household income at or below 125% of the poverty level to be eligible.
