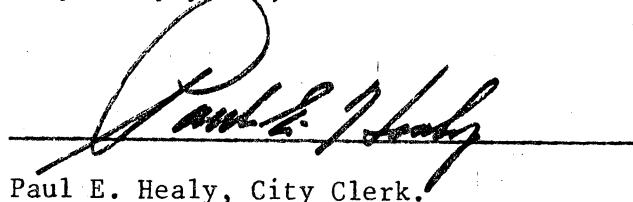
Dear Sirs:

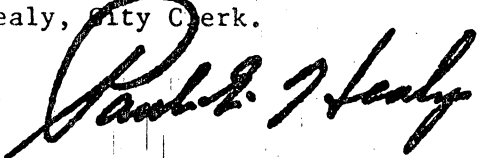

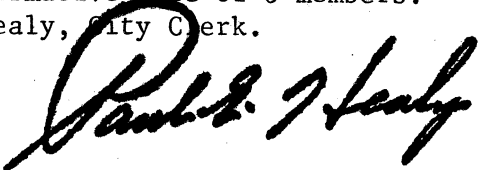
