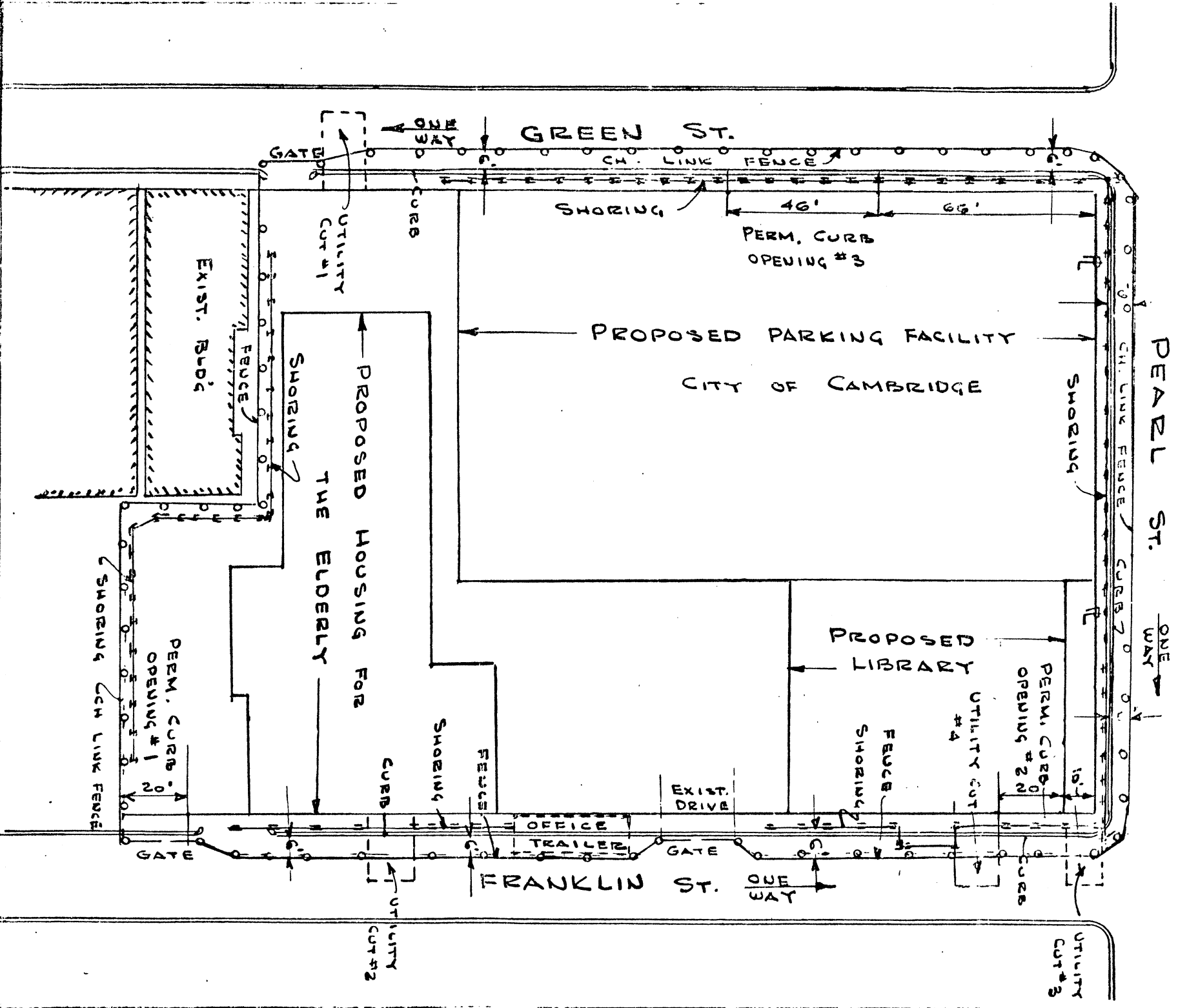

As a result, during and after a rainfall, water accumulates in this area and it floods the sidewalk to a degree that passing to and from the above numbered premises is not possible without getting wet. The water then flows into adjacent yards which do not have catch basins and as a further result stagnant ^{water} remains for weeks both at the curb and in the yards. During the winter months, the situation is somewhat worsened as ice forms in the same areas of the curb, sidewalks and yards and after a winter thaw the area is impassable.
