AN ORDINANCE

In amendment to an ordinance formerly entitled: "The General Ordinances of the City of Cambridge" as revised in 1972 and now designated as "The Code of the City of Cambridge."

Be it ordained by the City Council of the City of Cambridge as follows:

Chapter Eleven entitled: "Health and Housing," Article III entitled: "Massage Service Regulations," is hereby amended by striking out the present section 11-23 entitled: "Hours," and substituting in place thereof the following new section 11-23 which shall read as follows:

Section 11-23. Hours.

No massage business shall be kept open for any purpose between the hours of 12:00 p.m. and 7:00 a.m.
