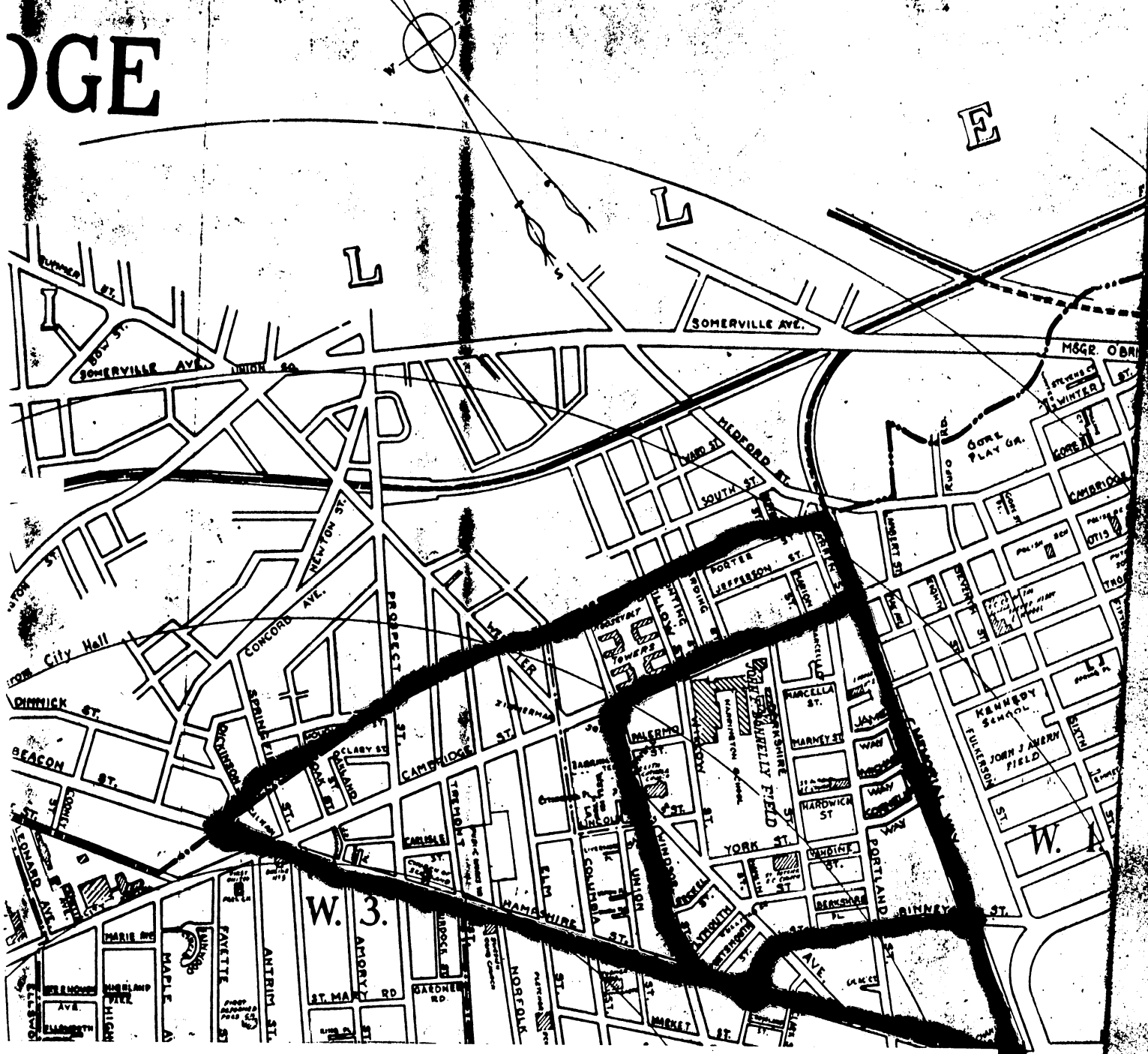

HOUSEBREAK ANALYSIS FOR BERKSHIRE/YORK/WILLOW

The area analyzed is square block within triangle on map above. The triangle denotes Neighborhood #3 of which the Berkshire/Willow area is part.

There have been 13 housebreaks in the Berkshire St area since the beginning of the year. This is slightly higher than average usually experienced by this area. Twelve of these 13 housebreaks were in Jan & Feb. There have been two arrests for housebreaks. One of the arrests was for a 209A violation, the other was for a known offender who we believe may be responsible for a number of breaks in the area.
