The undersigned respectfully pray

HE WHO HAS FOUND A FRIEND HAS FOUND A TREASURE.
WE KNOW THESE ARE THE WORDS OF OUR LORD AND SAVIOR
JESUS CHRIST. IS IT A FRIEND OR FRIENDS THAT
TAKE AWAY A VETERAN'S \$10,000.00 HE DIDN'T KNOW HE HAD?
IT IS FOR A FRIEND INDEED AND OF COURSE MYSELF THAT I
WRITE THIS LETTER. THE PURPOSE OF THIS LETTER IS TO
FILE A COMPLAINT AGAINST THE CAMBRIDGE CITY HOSPITAL.
I HOPE TO BE GOING TO COURT TO COLLECT IN A COURT
VICTORY \$350,000.00 BUT IF THEY PAY US \$25,000.00 IT
WILL MAKE A DIFFERENCE MAKING IT MUCH EASIER FOR
ME AND RITA TO LIVE. THE VETERANS ADMINISTRATION
SHOULD RETURN THE NEWLY WEDS MONEY: THAT'S MY WORK
A YEAR AFTER WE WERE MARRIED, REALLY IN LOVE; RITA
GOT THE STROKE BECAUSE, I DARE JUDGE; POLICE MADE
MARRIAGE IMPOSSIBLE FOR US. IN A RESTAURANT IN
WATERTOWN SQUARE, LAUGHING AT US WE WERE DEFINITELY
MASTURBATORS, THEY HAD GUNS ON THEM TOO: IN
WASHINGTON, D.C., TOO THEY HURT THIS DISABLED VETERAN
AND HIS LITTLE GERMAN-IRISH WIFE.

WE WERE BEING TREATED BADLY BECAUSE OF A
CONSERVATOR THAT WE COMPLAINED ABOUT TO
MISTER MELO AND MISTER LOUISE AT THE VETERANS
ADMINISTRATION: TO TAKE THIS 100% DISABILITY
CASE AWAY FROM US AND TO PUT US TO WORK BECAUSE
THE CASE C-7 386 746 HURTS US MENTALLY
AND PHYSICALLY. RITA GOT THE STROKE ABOUT
THREE WEEKS LATER. OBVIOUSLY, THOSE GOOD
MEN HAD NO TIME TO HELP US; THAT IS NO
REASON WHY THE CASE SHOULD CONTINUE TO
GO ON SINCE THAT VISIT TO THOSE MEN IN THE
MONTH OF MAY 1972, NEVERTHELESS IT GOES ON.

SAID TO ME, MR. PASQUALE WE WOULD LIKE
TO PUNCTURE THE LUMBA OF RITA BECAUSE
WE NEED MORE SILVER MATERIAL AND IF WE
DON'T SHE MAY GET MENINGITIS; I SAID TO
THEM NO NO NEVER NEVER DO THAT AND
THERE WAS EVEN A BEAUTIFUL FEELING OF
