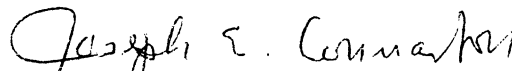

IN CITY COUNCIL

- WHEREAS: The United States Senate is expected to shortly take up consideration of a \$600 million comprehensive AIDS package that would provide funding to local governments for community education and outreach activities; and
- WHEREAS: The Comprehensive AIDS Research Information and Care Act (S. 1220) would establish a \$120 Million National Acquired Immunodeficiency Syndrome Information Program to carry out a variety of information dissemination activities; and
- WHEREAS: The program would provide grants to public and private non-profit organizations to establish demonstration programs focusing on community education and risk education activities; and
- WHEREAS: Other provisions of S. 1220 would include the establishment of a national information clearinghouse to disseminate free educational materials and a 24-hour information hotline; and
- WHEREAS: The bill authorizes \$150 Million for States to establish state education and prevention programs of which 50% of the funding must be passed through to local governments and community-based organizations; and
- WHEREAS: Other areas of the bill that would receive fundings include: care for children and individuals with AIDS, in-home care services, the development of foster care networks for infants with AIDS that have been abandoned in hospitals, and demonstration programs to develop long-term sub-acute care programs; and
- WHEREAS: This bipartisan legislation, sponsored jointly by Senators Edward Kennedy and Orrin Hatch (R-Utah), has been favorably reported by the Committee on Labor and Human Resources; now therefore be it
- RESOLVED: That this City Council go on record supporting the passage of the Comprehensive AIDS Research Information and Care Act (S. 1220); and be it further
- RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to the Clerk of the U. S. Senate for inclusion in the minutes of the Congressional Record on behalf of the entire City Council.

- WHEREAS: The United States Senate has voted to pass a budget that would "continue the trend of federal disinvestment in the families and children who live in cities...."cutting CDBG & UDAG funds by 5.8%, clean water funds by 3.5%, and assisted housing by 7.3%, yet still producing a deficit in excess of \$220 Billion; and
- WHEREAS: The United States House of Representatives has passed a budget which, while modest in urban funds at least freezes most programs and allows a 4% increase in Assisted Housing and Employment and Training; now therefore be it
- RESOLVED: That the Cambridge City Council, recognizing the continued needs of its people in areas such as housing, employment and public transportation, hereby requests its State Representatives and Senators in the United States Congress to support, through the Conference Committee, the House version of the budget; and be it further
- RESOLVED: That the City Clerk send a suitably engrossed copy of the resolution to each member of the Cambridge Congressional delegation.

## "PROPOSED MORATORIUM ON PATENTING OF ANIMALS"

- WHEREAS: The City of Cambridge is a center for advanced research in genetic engineering, and
- WHEREAS: The people of Cambridge recognize the potential of this new technology in finding cures for human illness and disease; and
- WHEREAS: The people of Cambridge recognize the potential of genetic engineering techniques in reducing animal suffering by replacing considerable experimentation on live animals; and
- WHEREAS: This technology provides the ability to create new genetically altered animals, such as a new kind of mouse for which the U.S. Patent office has recently issued a patent; and
- WHEREAS: The people of Cambridge are seriously concerned that unregulated, commercial exploitation of genetic manipulation techniques on animals may create serious environmental and ecological hazards; and
- WHEREAS: The people of Cambridge are concerned that new breeds of animals may be created which are commercially viable but ethically unacceptable, such as cows with gigantic udders which are in continuous pain and discomfort; and
- WHEREAS: A bill has been introduced in Congress to place a two year moratorium on animal patents in order to allow careful public consideration of the ramifications of such patenting; now therefore be it
- RESOLVED: That the City Council condemns that action of the U.S. Patent office in attempting to preempt congressional action on the proposed moratorium; and be it further
- RESOLVED: That the City Council expresses its support for the proposed moratorium; and be it further
- RESOLVED: That the City Council urges Congress to create strong regulatory mechanisms which would ensure that the public good is served by the introduction of a specific new animal before any commercial exploitation of such an animal is permitted; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to prepare a suitably engrossed copy of this Resolution to be sent to our Congressional Representatives and the Massachusetts Senators urging their support for quick, favorable action.
