I am hereby requesting the appropriation of a grant from the National Endowment for the Arts for \$50,000 to the Public Investment Fund Public Celebrations Extraordinary Expenditures Account to fund Phases III and IV of the public art project for Danehy Park. Phases I and II of the project included the creation of a glassphalt pathway and an environment at the park which includes plantings and a corridor of trees. Phases III and IV will focus on creating small and intimate gathering spots which will replan the existing picnic tables and chairs and will continue the educational component initiated in Phase I involving the public and school children.
