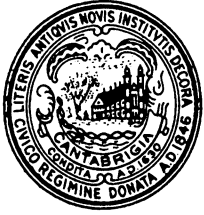



To the Honorable, the City Council:

Acceptance of four grants to the Cambridge Public Library is respectfully requested. Three of these grants are available through LSCA Title I Program - \$3,800 for the purchase of books and materials; \$2,709 for the purchase of materials related to providing health information; and \$800 to expand the collection of law books in the Library. The fourth grant is from the Massachusetts Arts and Humanities Council in the sum of \$350.00 for the restoration of 19th century architectural drawings of the Cambridge High School and blueprints of the Library.
