To the Honorable, the City Council:

Attached please find for your review an appropriation of \$140,000 to the Executive Department Other Ordinary Maintenance Account. The funds will be used over a twelve-month period to fund a newly created Office for Tourism, approved by the City Council at the December 13, 1993 Council meeting. The financing for the appropriation is from the loan repayment from the UDAG (Urban Development Action Grant) program. This appropriation supplements the \$60,000 given to the Chamber of Commerce and Cambridge Discovery for Tourism services in FY94.

Since this appropriation will conclude in the middle of FY95, it is my intention to recommend in the FY95 budget to the City Council, \$130,000 from Hotel/Motel tax money for the Office for Tourism.
