No State shall, without the consent of Congress lay any duty on tonnage, keep troops, or ships of war in peace, enter into any agreement or compact with another State, or with a foreign power, or engage in war, unless actually invaded, or in such imminent danger as will not permit delay.

Ammendment 10

POWERS RESERVED TO THE STATES AND THE PEOPLE

The Powers not delegated to the United States(which means the federal government) by the Constitution, nor prohibited by it to the States, are reserved to the States respectively (meaning the States individually), or the people.

Under the Authority of the Constitution and In the Name of The People of the United States of America and Based Upon the Facts Which I have Placed Upon the Public Record Which Will Hold Up In A Court of Law, all of which I will explain shortly I am Ordering the Council Not To Interfere With What I Have To Say.

Five weeks have passed since I asked the Federal Government Authorities to verify or deny charges of treason and war crimes by the President and the Congress

To the council I ask a question and request an answer.

Has any member of the council received an answer from the CIA, the FBI, the NSA The Attorney General's Office or the Commanders of the Armed Forces as to the verification, or proof of innocence of the charges and if so what did they to say ? Answer given, "No".

As the President has signed over his military authority to foreign commanders not sworn to uphold the Constitution and as there are foreign controlled military bases on United States soil under a secret agreement with weapons technology capacity unknown to the American citizens, occupied with foreign soldiers, taking orders from foreign commanders who are taking orders from UN foreign executives all of whom are not sworn to uphold and bear allegiance to the Constitution and whereas serious constitutional violations have been committed by the Congress and other dangerous

circumstances exist ★ I hereby declare a Constitutional state of "imminent danger as will not permit delay. Article 1, Section 10, Sub Section C.

The United States and the States do not have the authority to disobey, subvert or deny the powers of The Constitution and when they do their governmental authority becomes invalid.

The United States and the States are sworn to uphold and defend The Constitution and when they fail to do so their governmental authority becomes invalid.

In such cases governmental authority under Constitutional Amendment 10, is available (especially under circumstances of imminent danger as will not permit delay) to the States or the people. The Constitution does not say the States and then next to the people. It says, "OR" to the people. "OR" in this context means "either or" and either or means which ever happens FIRST.

I am The People, the situation of imminent danger as will not permit delay forces me to do what I must do to defend The

Constitution and The Nation, ★ Therefore

I am assuming national government authority

Madam Mayor with all due respect under the authority of the Constitution which is the Supreme law of the Land, in a state of imminent danger as will not permit delay due to all the reasons I have presented on public record, I am activating Directive Power of National Government Authority. Therefore I humbly request and order that I be allowed to finish which will not take long.

1-I am now ordering all those, I am ordaining with the power of arrest, or the power of office, to check my case, check The Constitution, seek whatever council you need, deciding whether or not it will stand up in court. Then if you are guided, proceed into action by serving the following Notice of Action which states

★ I am empowered with the power of authority, or to arrest as designated in the Constitution under the specifics of this National Directive by the order of The People as conveyed by Peter Valentine 37 Brookline St. Cambridge, MA 02139 4/8/1996 to be communicated to through the City Government of Cambridge. ★

2-★ I am now empowering all law officers of all US law enforcement agencies and all military personnel to arrest any executive or commanding officer who does not carry out my orders. And to replace that officer with the next officer in rank who will. ★

3-I now order the FBI to immediately arrest william clinton on charges of treason and war crimes against the American people.

4-I now order the FBI to investigate all federal legislative officials in regard to actions related to concentration camps, executive emergency orders, the federal reserve bank and any actions that are suspect in violation of The Constitution.

5-I now order Vice President Gore to take command of the Presidency to insure and improve national security and stability.

6-I ask General Colin Powell to be Administrator of Investigation of Federal Government Constitutional Violations empowered thereso to act independently and to arrest and bring to trial any United States government personnel engaging in violations of the Constitution or engaging in war crimes against the American People. He shall also be responsible for creating a book describing every single violation the Congress has committed.

7-I am ordering the FBI to inform him of this request immediately.

And if he accepts I order that he meet with President Gore immediately.

8-I am ordering that all federal security agencies facilitate the security of the people involved in these orders.

9-I am ordering the arrest of the owners of the Federal Reserve Bank on charges of fraud, treason, subversion of the Constitution and possible war crimes against the American People.

10-I am ordering the CIA, NSA, Attorney General's Office, the FBI and the Commanders of the Armed Forces to cease all involvement with local and foreign parties engaging in the overthrow of the United States of America this includes alien enemies. I will support you in these efforts.

11-I am ordering the Commanders of the Armed Forces to order all UN military forces to leave the territories of the United States of America immediately and I am ordering US military forces to surround and monitor those UN military forces and until they are gone.

12-I am ordering all US investigative and security forces that apply to thoroughly investigate all UN activities that have violated the United States Constitution, United States Government Activity and United States territorial sovereignty.

13-I am ordering a cancellation of the United States Presidential Elections until investigations of Federal Government Constitutional violations and war crimes are completed.

14-I am ordering all United States newspapers to print this National Directive exactly as it is, a copy of which can be obtained at the Cambridge City Clerk's Office.

15-I am continuing my request that the Council hold a public meeting with news media present to decide on the charges and if so bring the matter to the Supreme Court.

Finally to the People of the United States of America I believe a thorough National Review of everything that has happened to our Constitution must occur and that a new Constitution more applicable to our diverse life styles and more secure in its ability to prevent our government from being manipulated by hostile forces must be written by a process whereby the entire nation participates.

So Be It Ordered By The Will, The Blood, The Sweat and The Tears of The People.

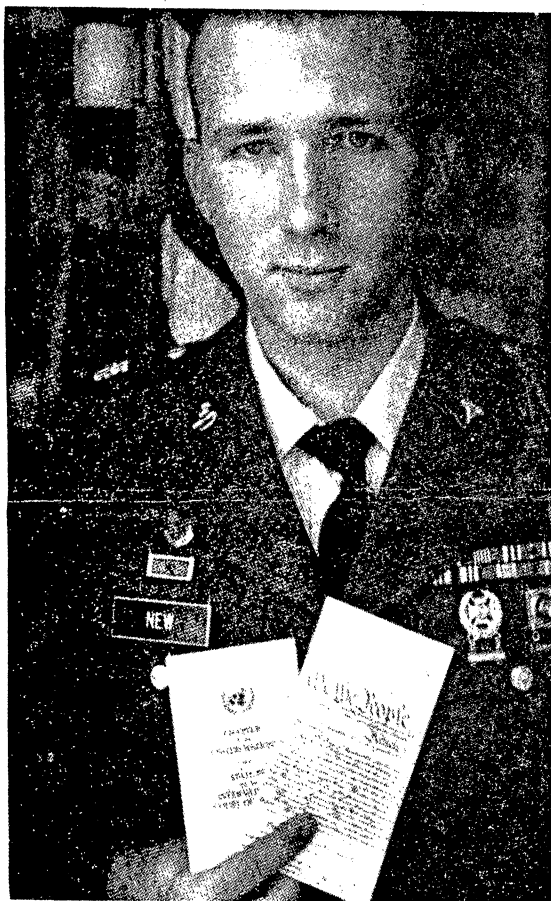

In 1979, when I was just beginning to strike the first feeble blow "for liberty" inside the Phoenix Police Department, it was as if I were completely alone. It was lonely indeed to be the **first** to speak out and ask for fellow officers to stand up and say NO to the Officer's CODE OF SILENCE, to unethical, unlawful and unConstitutional orders or activities on the part of our brethren and/or government.

In those hard first years of severe pressure and persecution from my own department and from state and federal police agencies, God gave me many blessings. Specifically, He brought to my side "angels" from the private sector in the form of Theresa & Bob Huebner. Soon after, another "angel", the **first** and very brave police officer from Mesa, Arizona, named Rick Dalton. Even while watching the persecution I was undergoing for my stand, this dear brother, jumped right into the "fire" with me. These few great Americans helped me take to other officers and soldiers a strange and seemingly new (but actually very old) idea, one that had long since been forgotten by many: namely, that police officers and soldiers should **know, understand and live strictly by their sworn oath.**

That oath outlined our **duty and responsibility**, not to the "majority", not to "the system", but to every one of the SOVEREIGN American people: to protect and defend the **People** and the **Constitution**, EVEN, if necessary, from an out-of-bounds governmental system.

A "NEW" CHALLENGE TO THE GLOBALIST PLAN

This past August, my dedicated staff and I were absolutely ecstatic to learn of a lone, brave, young American soldier by the name of Michael G. New, who was standing up against the entire anti-God, anti-Freedom, anti-American United Nations, and at the same time, against the Socialist, globalist members of our own government. (Michael is a 22 year-old medic with the Army's Third Infantry Division stationed in Germany.) For me, after reading the fax, there came immediately a familiar old sense of loneliness and persecution which I had felt a decade and a half before while on the Phoenix Police force. I read the memo and stopped to thank God for the courage and example that this young soul was exhibiting to his fellow soldiers, to the American people and his country. I could feel deeply his loneliness and fear of the unknown, as he stood in service to his own HIGHER AUTHORITY, and in opposition to the United States globalist agenda.

The two firings which I experienced so many years before because of my stand for the Constitution flashed through my mind. I said a quick prayer that now today it might be different for this young man. But, alas, on the 10th of October brother Michael's unit was ordered to fall out for formation in the uniform of a foreign power, with UN cap and insignia. Michael declined, and appeared instead in his usual U.S. Army greens. He was immediately sent to HQ to await the consequences. What Michael knows and is not afraid to demonstrate, is that the United Nations is a pro-Communist, world government organization which has as one of its main goals the destruction of every free and independent nation, the U.S. included, which he and you and I swore to serve and protect from all enemies.

Having met Michael's father, Mr. Daniel New, in Texas last month, and after having interviewed him a number of times on my international short wave radio program, I now know where Michael gets his strength of character, his love of country, and his great spiritual dedication. You see, Michael is a Christian and knows that he must answer to a much, much HIGHER AUTHORITY for his actions here on earth. This young man will be all right, because he is going to **DO what is right**, regardless of the consequences meted out to him by the much lower authorities within earthly governments. As a tribute to this wonderful, strong, God-fearing, American hero, I cite for you the very words this soldier spoke, which placed him in direct contravention to the entire Luciferian world government system. Here is what Army Spc. Michael New said, and the questions he asked:

- "I took an oath to the Constitution of the United States, and I can find no reference to the United Nations in it anywhere."
- "I am not a UN soldier."
- "It is not clear to me why I have to change my uniform in order to represent my country."
- "By what authority can you transfer my loyalty without my permission?"

The Army's first answer came from Michael's Lieutenant: "Well, soldier, you enlisted in the Army, and that oath you took was to obey orders from your chain of command and we're saying, 'WEAR IT!'"

About those orders that were to be handed down later in October, Specialist New said, "I told my superiors that I am an American soldier and will serve as a medic where I am sent and will seek to help my fellow soldiers. But, I am not going to wear that uniform. I believe they (the UN forces) are a foreign government. For the same reason, I won't wear a Russian uniform or salute a Russian flag."

Michael says that in one sense, he is not alone. "...many other soldiers agree with my stand, and are very frightened about what has happened to our military and country. But, they have wives and kids and retirement to consider, and are afraid to speak up."

(I remember hearing the same excuses from law enforcement, as we started Aid & Abet Police Newsletter in the early 80's. "I can't stand up and speak out about these immoral, un-Constitutional activities; I've got to think of my family, my retirement". But what we all better start to understand is this: **If** the globalists do succeed, none of us is going to want to live in the Godless, totalitarian, slave state that will be the result. You'd be hard-pressed to call it a **life**; more like bare existence. The government has **meant** to create dependency, locking the people in by means of welfare benefits, retirement and pension plans; these are the **chains** that will

bind us and our families to the planned world slave system. **"Man will not buy nor sell unless he accepts the mark" [the chains].** Sound familiar? Oh, brothers and sisters, how short-sighted, how AFRAID, we are!)

Colonel Ronald D. Ray (USMC, Ret.) is providing legal counsel for Michael, having been retained by Michael's parents, Daniel and Suzanne New, of the Houston, Texas area. Col. Ray is a former Deputy Assistant Secretary of Defense. In his words, Michael **"...has posed questions of tremendous historic importance. He is acquainted with the U.S. Constitution and the principles it embodies, and the contrary principles found in the UN Charter. He's in a very strong factual position as well, because the Army's gradual and increasing involvement in UN operations places U.S. soldiers in a militarily vulnerable and morally untenable position."**

The Colonel goes on to say, **"Michael knows that the United Nations is based upon a Charter which says that all rights are derived from the U.N.. This is very dissimilar from the U.S. Constitution which holds, as does the Declaration of Independence, that unalienable rights of life, liberty and property are God-given rights that no man or government can abridge."**

In response to massive publicity generated by Americans in support of Michael's position, those "brave" military leaders are seeking to keep the punishment of this soldier quiet. They drew up an Article 15 reprimand (a non-judicial procedure) for Michael to sign, hoping that he could then be gone without a fight. But, as no surprise to anyone who knows Michael, he refused to accept an Article 15. SO...THE FAT'S IN THE FIRE, leaving the military with just two other options: #1) Do what is **right**, and allow all sworn officers to start **upholding their oath to defend and protect the American Constitution and its people from a monstrous enemy, the United Nations, or #2) Try to court martial a brave patriotic American soldier who demands his right to do what is right and uphold his sworn oath of office to protect our nation from all enemies, internally and externally (and from those in the government ranks who have sold their allegiance for a mess of pottage).**

Are we surprised that Michael's Army superiors chose option #2? Well, at this writing, our brave young hero awaits Court Martial for the "crime" of upholding his oath **and for disobeying a direct order to violate it.**

Col. Ray has informed us that the preliminaries for the Court Martial are underway and that it will be conducted, and possibly concluded, in November.

LET OUR VOICES BE HEARD - NOW!

NOW is the time for freedom-loving people everywhere to come to the aid of their countries. The outcome of this case will impact every soldier and every police officer in whatever nation of the world.

Funds for legal defense are greatly needed. Michael New will have to be "made an example " by the occupied government of the United States, so that our Republican and Democratic Socialist/globalist "leaders" can rest easy that more patriotic soldiers (perhaps even in other countries) will NOT be following Spc. New's heroic lead in standing against UN world despotism. For just where would the New World Order crowd be, if their ENFORCEMENT ARM will not enforce their Godless, Socialist "peace" upon the masses??

Says brother Michael New: **"If they kick me out of the Army, if they send me to jail, I want to know in my mind, after all this is over, that I did what I thought was right in the eyes of God."**

Already, Michael has received several thousands of letters. Attorney Col. Ray says that all of our letters of support will be used in court to show that the people of America and other nations support this soldier in his stand. I ask you to do these things right now to help:

- 1) Michael and his family say that most important is to **pray** that God's will be accomplished.

- 3) Write, call or fax to all of your federal and state representatives. Do this often, not just once.
