ORDERED:

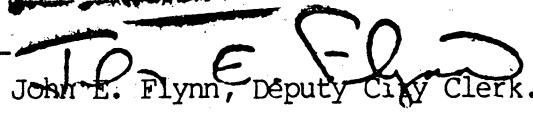
