As you know we have a photocopy machine in several departments of the City. The responsibility for paying for this service apparently lies with my office. It was my understanding that the individual departments were to pay for the machines and it has just recently come to my attention that this has not been done. I have been advised by the Royfax Company, which company leased this equipment to us, that the City has an outstanding indebtedness to the extent of \$22,300.00.


