The proposed curb cut and parking does not comply with the requirements of the Cambring Zoning Ordinance.

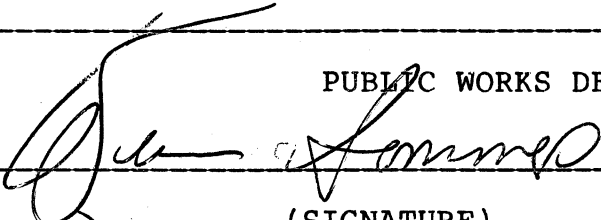
The parking shown is within the required front yard setback of 10 feet.

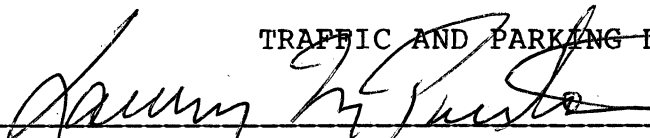

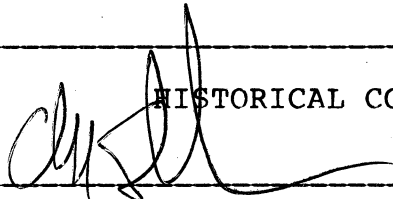
