- ORDERED: That the City Manager be and hereby is requested to provide a sum sufficient to pay a staff person to be assigned to this committee.

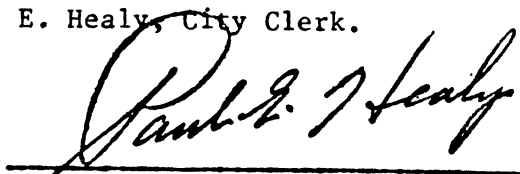
