NOTICE OF PUBLIC HEARING

To Members of the General Court, Mayors of Each City, Selectmen of Each Town, and
Boards of Public Welfare

Notice is hereby given that the Department of Public Welfare shall conduct a hearing by its Advisory Board on the adoption of rules and regulations of the Department relative to:

1. Certain revisions in the Medical Assistance Program. These revisions include but are not limited to fee schedules promulgated as a part of the Department's Medical Care Plan known as and numbered as follows:

Fee Schedule IV	-	Visiting Nurse Associations
Fee Schedule VI	-	Dental Services
Fee Schedule VII	-	Eye Examinations, Treatments and Eyeglasses
Fee Schedule X	-	Laboratory Services
Fee Schedule XI	-	Medical and Surgical Services or Procedures
Fee Schedule XVI	-	Ambulance Rates
New Fee Schedule XVII	-	Chiropractors' Services

and any other proposals received before the Public Hearing.

Fee Schedule XI was most recently revised in accordance with the provisions of Chapter 30A of the General Laws. This and other fee schedules are on file with and may be examined at the office of the Secretary of State, State House, Boston and at the office of the Department of Public Welfare, 600 Washington Street, Boston. The proposed fee schedules for the other services may be examined at the Department of Public Welfare, 600 Washington Street, Boston.

2. Certain revisions of Rule 7 of the Department under Chapter 118 of the General Laws. This rule concerns a change in financial eligibility and exemptions in the program of Aid to Families with Dependent Children.

The hearing will be held at Room 436, State House, Boston, at 10:00 A.M. on Thursday, September 14, 1967.

If interested parties have any data, views, or arguments concerning these regulations, they may submit same in writing to said Advisory Board, Department of Public Welfare, 600 Washington Street, Boston, prior to said hearing, or orally or in writing at said hearing.
