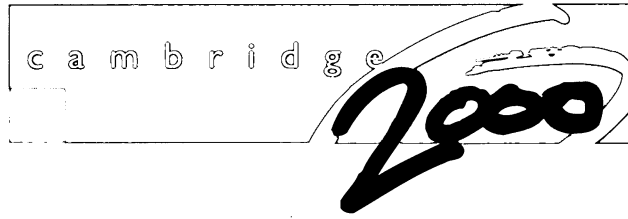

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$43,318 in the Grant Fund of the Human Services Salary & Wages Account (\$13,638) and Other Ordinary Maintenance Account (\$29,680). The Massachusetts Department of Education has awarded an increase to the Community Learning Center (CLC) for the Adult Basic Education Grant. Funds will be used to support the salaries of four part-time ESL teachers and one computer ESL teacher. The CLC will be adding four ESL classes and a computer class, and renovating the back room of 19R Brookline Street to serve as a computer lab for student use.
