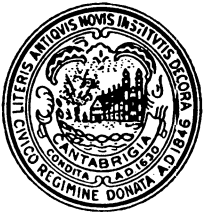

To: B-2, Postage - \$125.00

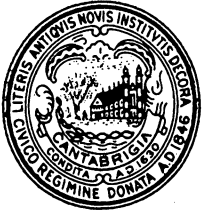


