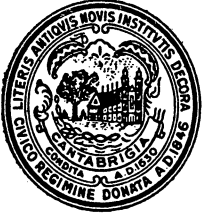

The above amounts to be provided by transfer from available funds from Auditing A1-Permanent Employees.

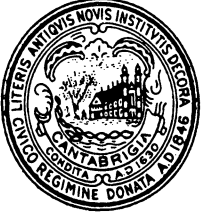
This transfer is necessary to maintain the efficiency of this department, and to expedite processing the backlog of accumulated work.


