
I respectfully request that the following transfer of funds from the A-1 account be approved to provide the necessary money to meet the expense of the following account.

To:	C-16, Wearing Apparel	1,000.00

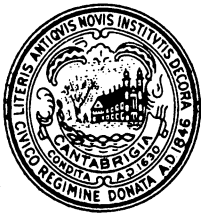


