ORDERED: That the City Manager be and hereby is requested to immediately develop and implement a fund to assist non-profit agencies, based on emergency need, with funding for existing programs which have faced severe funding cutbacks, particularly those agencies serving the City's linguistic minorities and to report back to the City Council on his actions by January 25, 1993.
