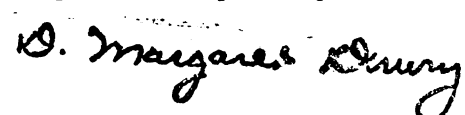

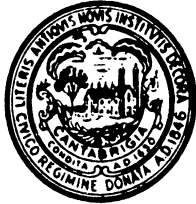

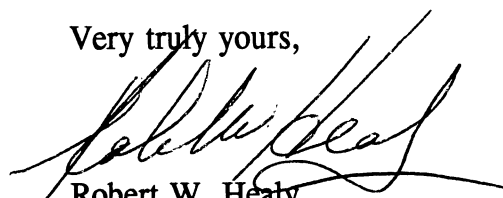

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$102,000.00 in the Grant Fund of the Department of Human Services Other Ordinary Maintenance Account from the U.S. Department of Housing and Urban Development. The Federal Emergency Shelter Grant is awarded annually to the department under the Stewart B. McKinney Homeless Assistance Act.
