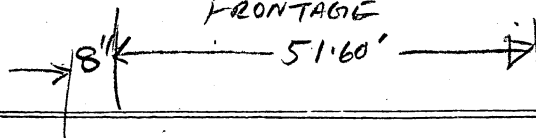
ELECTRIC WIRE POST.

FIRE HYDRANT

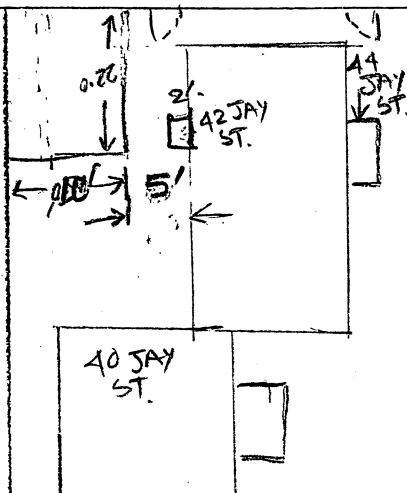

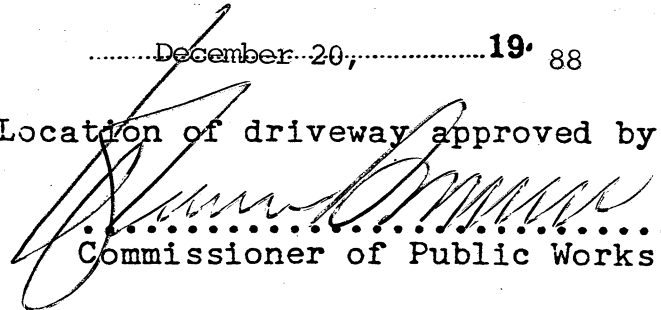
