I hereby request an appropriation in the amount of \$58.00 to reimburse Walter Holland, employee of the Public Works Department, for damages in this amount.

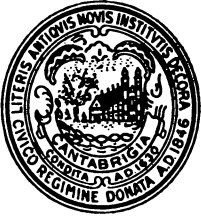
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Walter Holland, in which there was a judgment of \$58.00.


To the Honorable, the City Council,
