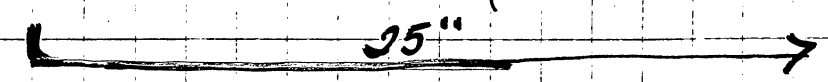


asking for curb cut here at Gate

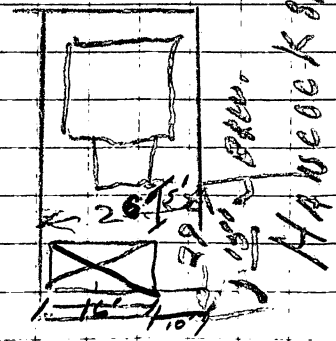


REAR OF 470 FRANKLIN ST

470 FRANKLIN ST

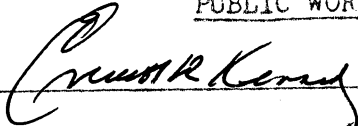
