- WHEREAS: Matthew's murder is an extreme example of the violence perpetrated against gay and lesbian individuals throughout this country; and
- WHEREAS: As surely as these acts of violence are engendered by fear, the fear is fueled by the repeated branding of people with an innate difference in sexual orientation as sinful, diseased, un-American and a subhuman threat to "normal values;" and
- WHEREAS: Hate crime laws, which do not exist in Wyoming, can play an important part in protecting the safety of gay and lesbian individuals, so long as the laws cover hate crimes based on the victim's sexual orientation, which the federal hate crime law does not cover; and

- WHEREAS: Most important to the well being and safety of the gay and lesbian members of our community, and the community as a whole, is respect for the civil and human rights of gay and lesbians persons and a steadfast refusal to tolerate the demonizing of homosexuals that feeds the fear in which hate flourishes; now therefore be it
- RESOLVED: That the City Council go on record extending its deepest sympathy to the family and friends of Matthew Shepard for their loss; and be it further
- RESOLVED: That the City Council go on record urging the members of the Massachusetts Congressional Delegation to support the inclusion of crimes based on the victim's sexual orientation in the federal hate crime law by passage of the Hate Crimes Prevention Act (H.R. 3081; S 1529); and be it further
- RESOLVED: That the City Council go on record acknowledging the connection between the de-humanizing demonization of homosexuals and crimes of violence against them and urge all Cantabrigians to re-affirm their commitment to the civil and human rights of the gay and lesbian members of the Cambridge Community; and be it further
- RESOLVED: That the City Clerk be and hereby is requested to forward a suitably engrossed copy of this resolution to the family of Matthew Shepard and the members of the Massachusetts Congressional delegation on behalf of the entire City Council.
