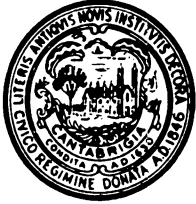
PROPERTY TAX RATE CLASSIFICATION.

Under the laws of the Commonwealth the city has the option of taxing residential and commercial/industrial property at different tax rates. At this public meeting, the City Council will review tax rates proposed by the City Manager and the Board of Assessors. The tax rates voted will reflect the City's property tax levy for FY 95, the addition of new taxable property to the City's tax base, the Assessors' annual reassessment program to adjust values to January 1, 1994, and the City Council's decision regarding distribution of the tax burden between commercial and residential properties.

The Cambridge City Council will entertain comment and opinion from interested citizens and taxpayers.
