Attached is an order requesting the appropriation of \$275,500.00 in the Grant Fund from Massachusetts Department of Education to the Human Services Salary & Wages Account \$240,114.00, Other Ordinary Maintenance Account \$35,070.00 and Travel & Training Account \$316.00.
