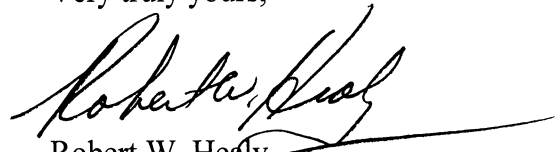

I am hereby requesting an appropriation of \$30,240.00 in the Grant Fund of the Human Services Salary and Wages Account (\$29,448.00) and Other Ordinary Maintenance Account (\$792.00). The Massachusetts Department of Education has awarded this grant to the Community Learning Center to provide ESL classes for employees of several Harvard Square workplaces.
