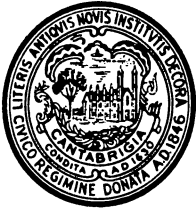


To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of \$67,395.08 to the Department of Human Service Programs grant fund, Other Ordinary Maintenance Account.

This appropriation will fund the annual summer food service program sponsored by the Department and funded by the State Department of Education, Bureau of Nutrition. Participation in the food service program is open to all Cambridge agencies which operate a full-day summer program.
