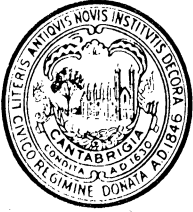
SEC. 1413.0 BUILDING CODE. . PROJECTING SIGNS

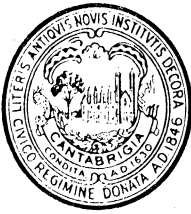

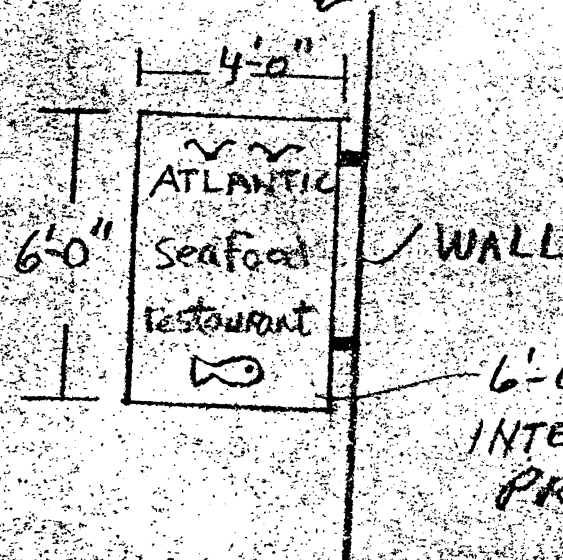
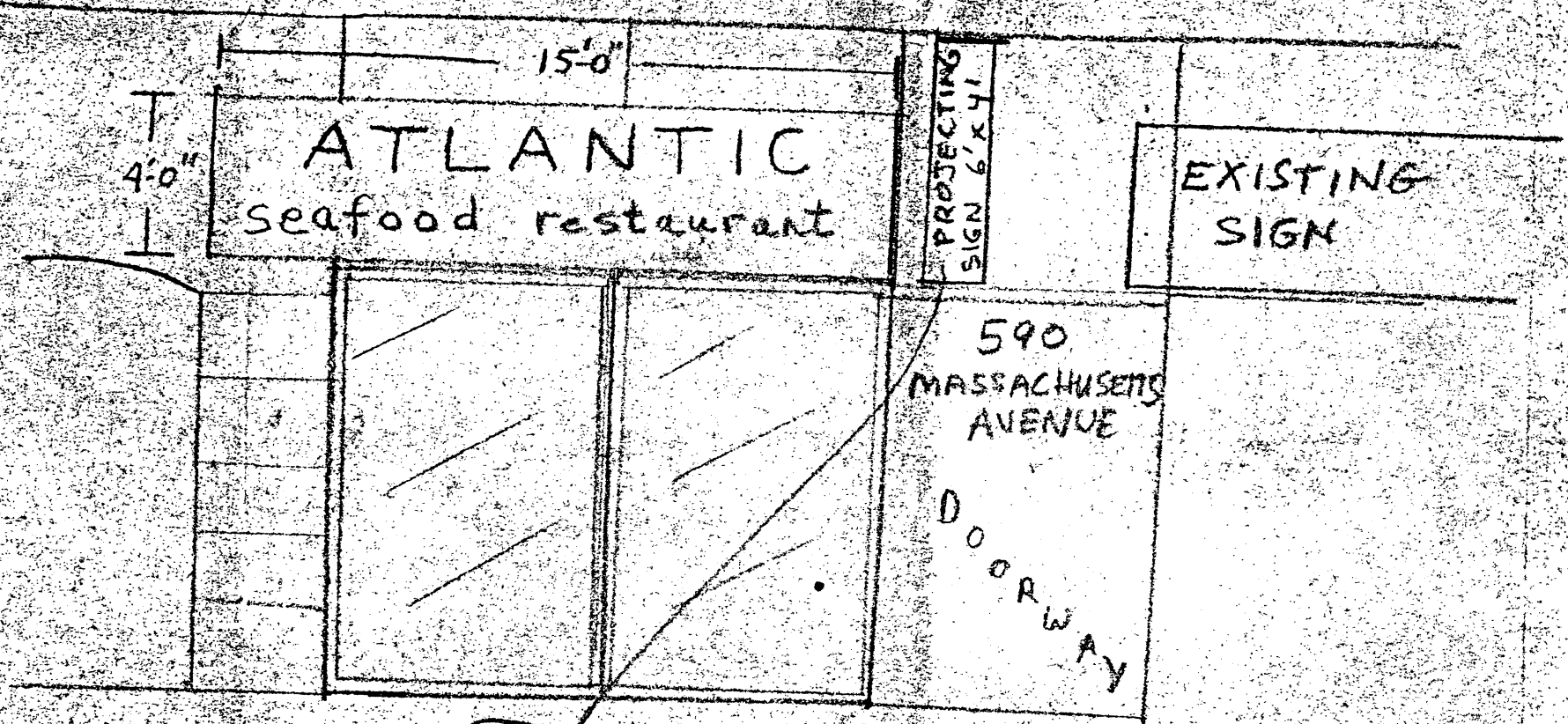
