Notice is hereby given that a public hearing will be conducted by the Massachusetts Industrial Finance Agency ("MIFA") at ten o'clock in the morning, on Wednesday, July 24, 1985, at 125 Pearl Street, 3rd Floor, Boston, Massachusetts, on the proposal of ENSECO Incorporated that MIFA approve a project to be located at 205 Alewife Brook Parkway, in the City of Cambridge, Massachusetts, (the "Municipality") and consisting generally of purchase of .5718 acres of land, rehabilitation of existing building and construction of 10,000 square foot addition thereto, and purchase of laboratory and data processing equipment, and the estimated cost of such project in an amount of approximately \$6,937,800, and authorize the financing of such costs by the issuance by MIFA, acting under and pursuant to Massachusetts General Laws, Chapters 23A and 40D, of industrial revenue bonds in an aggregate principal amount of approximately \$3,250,000, which bonds will not constitute a debt or pledge of the faith and credit of MIFA or of The Commonwealth of Massachusetts.
