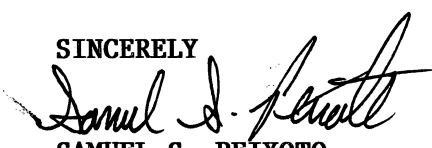

AND WAS AN OFFICER WHEN IT WAS RAIDED. IN THE TIME SINCE HE HAS BEEN PROMOTED.
FURTHERMORE DEPUTY SUPERINTENDANT HALLS BROTHER WAS AN INMATE AT THE PRISON IN WHICH
I WORKED AND I BELIEVE SHE AS WELL AS FORMER COMMISSIONER ANDERSON CONPIRED WITH
DR GUY SEYMOUR TO FAIL ME IN THE ONLY WAY THAT THEY COULD .
ALSO ANDERSON WROTE A LETTER TO THE LAWRENCE POLICE CHIEF ORDERING THAT HE NOT
HIRE MY BROTHER FOR THE POSITION OF POLICE OFFICER.
SINCE THAT TIME IN 1994 i have not been able to find work because of
SEYMOUR AND HIS FABRICATED REPORT.IT IS A BLACK CLOUD OVER MY HEAD WHICH I WILL NEVER
NEVER ESCAPE. MY LIFE IS RUINED.
I ASK THAT YOU INVESTIGATE THE POLICE DEPARTMENT AS WELL AS CITY MANAGER ROBERT
HEALY WITH RESPECT TO POLICE HIRING PRACTICES. IF I CAN NOT
FIND EMPLOYMENT AS A POLICE OFFICER THEN I MUST MAKE THE CITY HELD
RESPONSIBLE. FOR THE TIME BEING I WILL REFRAIN FROM ANY USE OF FORCE
AS LONG AS I AM TREATED WITH HONESTY.
