AN ORDINANCE

In amendment to an ordinance formerly entitled: "The General Ordinances of the City of Cambridge" as revised in 1972 and now designated as "The Code of the City of Cambridge."

Be it ordained by the City Council of the City of Cambridge as follows:

Chapter 11, entitled: "Health and Housing" is hereby amended by adding a new paragraph entitled: "Article III. Massage Service Regulations" which will read as follows:

ARTICLE III. MASSAGE SERVICE REGULATIONS

SECTION 11-10. DEFINITIONS.

For the purpose of this ordinance, the following words and phrases shall have the meanings respectively ascribed to them by this section.

(a) Employees. Any person over eighteen (18) years of age, other than a massagist, who renders any service in connection with the operation of a massage business and receives compensation from the operator of the business or patrons.

(b) Licensee. The person to whom a license has been issued to own or operate a massage establishment as defined herein.

(c) Massage. Any method of pressure on or friction against, or stroking, kneading, rubbing, tapping, pounding, vibrating, or stimulating of the external parts of the human body with the hands or with the aid of any mechanical electrical apparatus or appliances with or without such supplementary aids as rubbing alcohol, liniments, antiseptics, oils, powder, creams, lotions, ointment or other such similar preparations commonly used in the practice of massage, under such circumstances that it is reasonably expected that the person to whom the treatment is provided or some third person on his or her behalf will pay money or give any other consideration or any gratuity therefor.

(d) Massage Establishment. Any establishment having a source of income or compensation derived from the practice of massage as defined in Subsection (c), and which has a fixed place of business where any person, firm, association or corporation engages in or carries on any of the activities as defined in Subsection (c).

(e) Massagist, Masseur or Masseur. Any person who, for any consideration whatsoever, engages in the practice of massage as defined in Subsection (c).

(f) Outcall Massage Service. Any business, the function of which is to engage in or carry on massages at a location designated by the customer or client rather than at a massage establishment as defined in Subsection (c).

(g) Patron. Any person over eighteen (18) years of age who receives a massage under such circumstances that it is reasonably expected that he or she will pay money or give any other consideration therefor.

(h) Permittee. The person to whom a permit has been issued to act in the capacity of a massagist (masseur or masseuse) as herein defined.

(i) Person. Any individual, partnership, firm, association, joint stock company, corporation or combination of individuals of whatever form or character.

(j) Sexual or Genital Area. Genitals, pubic area, buttocks, anus, or perineum of any person, or the vulva or breasts of a female.

SECTION 11-11. PERMIT REQUIRED.

(a) Business license required. No person shall engage in or carry out the business of massage unless he has a valid massage business license issued by the City pursuant to the provisions of this ordinance for each and every separate office or place of business conducted by such person.

(b) Massagist's permit required. No person shall practice massage as a massagist, employee or otherwise, unless he has a valid massagist's permit issued to him the the City pursuant to the provisions of this ordinance.

SECTION 11-12. EXEMPTIONS.

This ordinance shall not apply to the following individuals while engaged in the personal performance of the duties of their respective professions:

(a) Physicians, surgeons, chiropractors, osteopaths, or physical therapists who are duly licensed to practice their respective professions in the Commonwealth of Massachusetts.

(b) Nurses who are registered under the laws of the Commonwealth of Massachusetts.

(c) Barbers and beauticians who are duly licensed under the laws of the Commonwealth of Massachusetts, except that this exemption shall apply solely to the massaging of the neck, face, scalp and hair of the customer or client for cosmetic or beautifying purposes.

(d) Practitioners of a therapeutic art that requires the application of massage techniques and which is endorsed as to its effectiveness by at least five physicians or clinical psychologists

duly licensed or registered by their respective states, at least two of which are so licensed or registered by The Commonwealth of Massachusetts, provided that such practitioners have completed at least 1,000 hours of instruction and supervised field work in the discipline, at least 100 hours of which is instruction in applied anatomy and 500 hours of which is instruction in deep muscle massage, and have been examined and certified by an independent board of examiners qualified to administer such examinations; and bona fide students of such therapeutic art who have completed at least 1,000 hours of instruction and supervised field work in the discipline, at least 100 hours of which is instruction in applied anatomy and 500 hours of which is instruction in deep muscle massage, and who practice the art under the supervision of a certified practitioner thereof, provided further that any such individual claiming exemption from this ordinance under this subparagraph (d) shall: (i) submit to the Commissioner of Health and Hospital his or her name, residential and professional address, and credentials to practice said art, sworn to under the pains and penalties of perjury, together with a certificate or other documentary evidence of such individual's preparation for the practice of said art; (ii) annually submit to said Commissioner a statement of condition upon a form provided by said Commissioner.

(e) Any other individual or establishment that the Commissioner of Health and Hospital may, by written regulation, specifically exempt if said Commissioner finds (1) that such individual or establishment provides the administration of massage pursuant to a bona fide athletic or educational event or function or (2) any establishment which is duly incorporated as a charitable corporation under Chapter 180 of the General Laws of Massachusetts and has received Federal Tax Exemption status under IRS Code 501 (c) (3), and provided further that any such establishment shall submit to the Commissioner of Health and Hospital duly certified copies of their Articles of Organization, By Laws, and Federal Tax exemption status, together with letters of reference as set forth in Section 11-13 (p) of this ordinance.

SECTION 11-13. APPLICATION FOR MASSAGE ESTABLISHMENT LICENSE.

Every applicant for a license to maintain, operate, or conduct a massage establishment shall file an application under oath with

the Commissioner of Health and Hospital upon a form provided by said Commissioner and pay a nonrefundable annual license fee, which shall be \$100 per year or any part thereof. Licensees who have already paid the license fee for the current (six (6) month) period shall not be required to pay an additional fee hereunder. Each application shall contain the following information:

(a) A definition of service to be provided.

(b) The location, mailing address and all telephone numbers where the business is to be conducted.

(c) The name and residence address of each applicant (hereinafter all provisions which refer to applicant include an applicant which may be a corporation or partnership).

(1) If applicant is a corporation, the names and residence addresses of each of the officers and directors of said corporation and of each stockholder of the corporation, and the address of the corporation itself, if different from the address of the massage establishment.

(2) If applicant is a partnership, the names and residence addresses of each of the partners including limited partners, and the address of the partnership itself, if different from the address of the massage establishment.

(d) The two (2) previous addresses immediately prior to the present address of the applicant.

(e) Proof that the applicant is at least eighteen (18) years of age.

(f) Individual or partnership applicant's height, weight, color of eyes and hair, and sex.

(g) Copy of identification, such as driver's license and social security card.

(h) Business, occupation, or employment of the applicant for three (3) years immediately preceding the date of application.

(i) The massage or similar business license history of the applicant; whether such person, in previously operating in this or another City or State, has had a business license revoked or suspended, the reason therefor, and the business activity or occupation subsequent to such action of suspension or revocation.

(j) All criminal convictions other than misdemeanor traffic violations, including the dates of convictions, nature of the crimes and place convicted.

(k) The name and address of each massagist who is or will be employed in said establishment.

(l) The name and address of any massage business or other establishment owned or operated by any person whose name is required to be given in Subsection (c) where the business or profession of massage is carried on.

(m) A description of any other business to be operated on the same premises or on adjoining premises owned or controlled by the applicant.

(n) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(o) Such other identification and information necessary to discover the truth of the matters hereinbefore specified as required to be set forth in the application.

(p) The names, current addresses and written statements of at least three (3) practicing physicians or clinical psychologists, licensed to practice in the Commonwealth of Massachusetts, that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and last from the Commonwealth. These references must be persons other than relatives and business associates.

Upon the completion of the above provided form and the furnishing of all foregoing information the Commissioner of Health and Hospital shall accept the application for the necessary investigations. The holder of a massage establishment license shall notify the Commissioner of Health and Hospital of each change in any of the data required to be furnished by this Section within ten (10) days after such change occurs.

SECTION 11-14. APPLICATION FOR MASSAGIST'S PERMITS.

Application for a massagist's business permit shall be made to the Commissioner of Health and Hospital in the same manner as provided above for massage establishment licenses, accompanied by the annual nonrefundable massagist's permit fee of \$25 per year or part thereof. The application shall contain but not be limited to the following:

(a) The business address and all telephone numbers where the massage is to be practiced.

(b) Name and residence address, and all names, nicknames and aliases by which the applicant has been known, including the two previous addresses immediately prior to the present address of the applicant.

(c) Social Security number, driver's license number, if any, and date of birth.

(d) Applicant's weight, height, color of hair and eyes, and sex.

(e) Written evidence that the applicant is at least eighteen (18) years of age.

(f) A complete statement of all convictions of the applicant for any felony or misdemeanor or violation of a local ordinance, except misdemeanor traffic violations.

(g) Two front-face portrait photographs taken within thirty (30) days of the date of application and at least two (2) inches by two (2) inches in size.

(h) The massage or similar business history and experience (10 years) prior to the date of application, including but not limited to whether or not such person in previously operating in this or another City or State under license or permit has had such license or permit denied, revoked, or suspended and the reasons therefor, and the business activities or occupations subsequent to such action of denial, suspension or revocation.

(i) The names, current addresses and written statements of at least three (3) practicing physicians or clinical psychologists, licensed to practice in the Commonwealth of Massachusetts, that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and lastly from the Commonwealth. These references must be persons other than relatives and business associates.

(j) A medical certificate signed by a physician, licensed to practice in the Commonwealth of Massachusetts, within seven (7) days of the date of the application. The certificate shall state that the applicant was examined by the certifying physician and that the applicant is free of communicable disease. The additional information required by this Subsection shall be provided at the applicant's expense.

(k) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(l) Written declaration by the applicant, under the penalty of perjury, that the foregoing information contained in the application is true and correct, said declaration being duly dated and signed in the City.

SECTION 11-15. ISSUANCE OF LICENSE OR PERMIT FOR A MASSAGE ESTABLISHMENT.

The City of Cambridge, acting by and through its Commissioner of Health and Hospital shall issue a license for a massage establishment or a permit for a masseur or masseuse, if all requirements for a massage establishment or massagist permit described in this Ordinance are met unless it finds:

(a) The correct permit or license fee has not been tendered to the City, and, in the case of a check, or bank draft, honored with payment upon presentation.

(b) The operation, as proposed by the applicant, if permitted, would not comply with all applicable laws, including, but not limited to, the City's building, zoning, and health regulations.

(c) The applicant, if an individual, or any of the stockholders and any of the officers and directors, if the applicant is a corporation, or any of the partners, including limited partners, if the applicant is a partnership, or the holder of any lien, of any nature, upon the business and/or the equipment used therein, and the manager or other person principally in charge of the operation of the business, have been convicted of any of the following offenses or convicted of an offense without the Commonwealth of Massachusetts that would have constituted any of the following offenses if committed within the Commonwealth of Massachusetts:

(1) An offense involving the use of force or violence upon the person of another that amounts to a felony.

(2) An offense involving sexual misconduct.

(3) An offense involving narcotics, dangerous drugs or dangerous weapons that amounts to a felony.

The City of Cambridge may issue a license or permit to any person convicted of any of the crimes described in Subsection (1), (2), or (3) of this Section if it finds that such conviction occurred at least five (5) years prior to the date of the application and the applicant has had no subsequent felony convictions of any nature and no subsequent misdemeanor convictions for the crime mentioned in this Section.

(d) The applicant has knowingly made any false, misleading, or fraudulent statement of fact in the permit application or in any document required by the City in conjunction therewith.

(e) The applicant has had a massage business, masseur, or other similar permit or license revoked, or suspended by the City or any other State or local agency within five (5) years prior to the date of the application. If the application for a permit or license is denied, the applicant shall not be allowed to reapply within one (1) year from the date of denial.

(f) The applicant, if an individual, or any of the officers and directors, if the applicant is a corporation, or any of the partners, including limited partners, if the applicant is a partnership, and the manager or other person principally in charge of the operation of the business, is not over the age of eighteen (18) years.

(g) In making his decision the commissioner shall consider the number of existing and proposed massage establishments in the ward in which the instant applicant desires to locate.

SECTION 11-16. APPROVAL OR DENIAL OF APPLICATION.

The Commissioner of Health and Hospital, acting by and on behalf of the City, shall act to approve or deny an application for a license or permit under this Ordinance within a reasonable period of time and in no event shall said Commissioner act to approve or deny said license or permit later than ninety (90) days from the date that said application was accepted by the Commissioner. Every license or permit issued pursuant to this Ordinance will terminate at the expiration of one year from the date of its issuance unless sooner suspended or revoked. If the Commissioner fails to act within said ninety (90) days, then the application will be deemed to be approved.

SECTION 11-17. POSTING OF LICENSE.

(a) Every massagist shall post the permit required by this Ordinance in his work area.

(b) Every person, corporation, partnership, or association licensed under this Ordinance shall display such license in a prominent place.

(c) Every individual or establishment issued an exemption under Section 11-12 of this ordinance shall display such exemption certificate in a prominent place.

SECTION 11-18. REGISTER OF EMPLOYEES.

The licensee or person designated by the licensee of a massage establishment shall maintain a register of all persons employed at any time as masseurs or masseuses and their permit numbers. Such register shall be available at the massage establishment to representatives of the City of Cambridge during regular business hours.

SECTION 11-19. REVOCATION OR SUSPENSION OF LICENSE.

Any license issued for a massage establishment may be revoked or suspended by the Commissioner of Health and Hospital, acting by and on behalf of the City, after notice and a hearing for good cause, or in any case where any of the provisions of this Ordinance are violated or where any employee of the licensee, including a masseur or masseuse, is engaged in any conduct which violates any of the State or local laws or ordinances at licensee's place of business and the licensee has actual or constructive knowledge by due diligence. Such permit may also be revoked or suspended by the Commissioner after notice and hearing, upon the recommendations of any City of Cambridge health inspector, that such business is being managed, conducted or maintained without regard to proper sanitation and hygiene. As used in this section, notice shall mean written notification of the time and place of hearing and the basis for contemplated revocation or suspension, served by first class mail, postage prepaid, to applicant's address as stated in the license. Said notice shall be posted seven (7) days prior to the hearing date.

SECTION 11-20. REVOCATION OF MASSEUR OR MASSEUSE PERMIT.

A masseur or masseuse permit issued by the Commissioner of Health and Hospital shall be revoked or suspended where it appears that the masseur or masseuse has been convicted of any offense which would be cause for denial of a permit upon an original application, has made a false statement on an application for a permit, or has committed an act in violation of this Ordinance. Notice of such revocation or suspension shall be issued in the manner provided for in Section 11-9.

SECTION 11-21. OPERATING REQUIREMENTS.

(a) Every portion of the massage establishment, including appliances and apparatus, shall be kept clean and operating in a sanitary condition.

(b) Price rates for all services shall be prominently posted in the reception area in a location available to all prospective customers.

(c) All employees, including masseurs and masseuses, shall be clean and wear clean, nontransparent outer garments, covering the sexual and genital areas, whose use is restricted to the massage establishment.

(d) All massage establishments shall be provided with clean, laundered sheets and towels in sufficient quantity and shall be laundered after each use thereof and stored in a sanitary manner.

SECTION 11-22. PERSONS UNDER AGE 18 PROHIBITED ON PREMISES.

No person shall permit any person under age eighteen (18) years to come or remain on the premises of any massage business establishment, as masseur, employee, or patron, unless such person is on the premises on lawful business.

SECTION 11-23. ALCOHOLIC BEVERAGES PROHIBITED.

No person shall sell, give, dispense, provide to keep, or cause to be sold, given, dispensed, provided or kept, any alcoholic beverage on the premises of any massage business.

SECTION 11-24. HOURS.

No massage business shall be kept open for any purpose between the hours of and

SECTION 11-25. EMPLOYMENT OF MASSAGIST.

No person shall employ as a massagist any person unless said employee has obtained and has in effect a permit issued pursuant to this Ordinance.

SECTION 11-26. UNLAWFUL ACTS.

(a) It shall be unlawful for any person, in a massage parlor, to place his or her hand or hands upon, to touch with any part of his or her body, to fondle in any manner, or to massage, a sexual or genital part of any other person.

(b) It shall be unlawful for any person, in a massage parlor, to expose his or her sexual or genital parts, or any portion, thereof, to any other person. It shall also be unlawful for any person, in a massage parlor, to expose the sexual or genital parts, or any portions thereof, of any other person.

(c) It shall be unlawful for any person, while in the presence of any other person in a massage parlor, to fail to conceal with a fully opaque covering, the sexual or genital parts of his or her body.

(d) It shall be unlawful for any person owning, operating or managing a massage parlor, knowingly to cause, allow or permit in or about such massage parlor, any agent, employee, or any other person under his control or supervision to perform such acts prohibited in Subsections (a), (b) or (c) of this Section.

(e) It shall be further unlawful for any permittee under this Ordinance to administer massage on an outcall basis as defined in Section 11-10(f). Such person shall administer massage solely within an establishment licensed to carry on such business under this Ordinance. Any violation of these provisions shall be deemed grounds for revocation on the permit granted hereunder. The restriction on outcall massage shall not apply to a permittee who performs outcall massage as defined herein upon a customer or client who, because of reasons of physical defects or incapacities or due to illness is physically unable to travel to the massage establishment. If any outcall massage is performed under this exception, a record of the date and hour of each treatment, and the name and address of the customer or client, and the name of the employee administering such treatment and the type of treatment administered, as well as the nature of the physical defect, incapacity or illness of said client or customer shall be kept by the licensee or person or employee designated by the licensee. Such records shall be open to inspection by officials charged with the enforcement of public health laws. The information furnished or secured as a result of any such inspection shall be confidential. Any unauthorized disclosure or use of such information by an employee of the City of Cambridge shall be unlawful.

SECTION 11-27. INSPECTION.

The Police Chief or his designee shall, pursuant to a validly issued search warrant, be authorized to inspect any massage business establishment which he (she) shall have reason to believe is operating in violation of this ordinance or any state law or regulation.

SECTION 11-28. SALE OR TRANSFER OR CHANGE OF LOCATION.

Upon sale, transfer or relocation of a massage establishment, the license therefor shall be null and void unless approved as provided in Section 11-15 provided, however, that upon the death or incapacity of the licensee or any co-licensee of the massage establishment, any heir or devisee or legatee of a deceased licensee, or any guardian of an heir or devisee of a deceased licensee may continue the business of the massage establishment for a reasonable period of time not to exceed sixty (60) days to allow for an orderly transfer of the license.

SECTION 11-29. NAME AND PLACE OF BUSINESS.

No person granted a license pursuant to this Ordinance shall operate the massage establishment under a name not specified in his license, nor shall he conduct business under any designation or location not specified in his license.

SECTION 11-30. TRANSFER OF LICENSE

No license or permit shall be transferable except with the consent of the Commissioner of Health and Hospital. An application for such transfer shall be in writing and shall be accompanied by fees prescribed in Sections 11-13 and 11-14. The written application for such transfer shall contain the same information as requested herein for initial application for the license or permit.

SECTION 11-31. RULES AND REGULATIONS.

The Commissioner shall have the authority to formulate rules and regulations necessary to uniformly enforce and administer the provisions of this ordinance, and to protect the health, safety, and welfare of the inhabitants of the City, provided that such rules and regulations do not conflict with the provisions set forth in this ordinance.

SECTION 11-32. VIOLATION AND PENALTY.

Every person, except those persons who are specifically exempted by this ordinance, whether acting as an individual owner, employee of the owner, operator or employee of the operator, or whether acting as a mere agent or independent contractor for the owner, employee or operator, or acting as a participant or worker in any way directly or indirectly who gives massages or operates a massage establishment of any of the services defined in this ordinance without first obtaining a license or permit and paying a fee to do so from the City of Cambridge or shall violate any provisions of the ordinance shall be punished by a fine not to exceed two hundred (\$200.00) dollars per violation. Each day's failure to comply with each provision of this ordinance shall constitute a separate violation.

SECTION 11-33. SEPARABILITY.

(a) If any section, subsection, sentence, clause, phrase or portion of the ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such provision and such holding shall not affect the validity of the remaining portions thereof.

(b) All ordinances in conflict herewith are hereby repealed.

(c) This ordinance shall be in full force and effect from and after its passage, provided, however, any person, partnership, corporation or association engaged in the operation of a massage business and every person engaged in the business or profession of massage, at the time of the enactment of this ordinance shall have _____ days in which to comply with the licensing provisions of this ordinance.

(k) Sexual or Genital Area. Genitals, pubic area, buttocks, anus, or perineum of any person, or the vulva or breasts of a female.

SECTION 11-13. APPLICATION FOR MASSAGE ESTABLISHMENT LICENSE.

Every applicant for a license to maintain, operate, or conduct a massage establishment shall file an application under oath with the Commissioner of Health and Hospital upon a form provided by said Commissioner and pay a nonrefundable annual license fee, which shall be \$100 per year or any part thereof. Licensees who have already paid the license fee the the current (six (6) month) period shall not be required to pay an additional fee hereunder. Copies of the application shall within five (5) days be referred to the Building Department and Fire Department. The departments shall within thirty (30) days inspect the premises proposed to be operated as a massage establishment and shall make written verification to the Commissioner of Health and Hospital concerning compliance with the codes of the City of Cambridge that they administer. The application shall further be referred to the Police Department for investigation of the applicant's character and qualifications. Each application shall contain the following information:

- (a) A definition of service to be provided.
- (b) The location, mailing address and all telephone numbers where the business is to be conducted.
- (c) The name and residence address of each applicant (hereinafter all provisions which refer to applicant include an applicant which may be a corporation or partnership).
 - (1) If applicant is a corporation, the names and residence addresses of each of the officers and directors of said corporation and of each stockholder owning more than ten percent (10%) of the stock of the corporation, and the address of the corporation itself, if different from the address of the massage establishment.
 - (2) If applicant is a partnership, the names and residence addresses of each of the partners including limited partners, and the address of the partnership itself, if different from the address of the massage establishment.
- (d) The two (2) previous addresses immediately prior to the present address of the applicant.
- (e) Proof that the applicant is at least eighteen (18) years of age.
- (f) Individual or partnership applicant's height, weight, color of eyes and hair, and sex..
- (g) Copy of identification such as driver's license and social security card.
- (h) One portrait photograph of the applicant at least two (2) inches by two (2) inches and a complete set of applicant's fingerprints which shall be taken by the Chief of Police or his agent. If the applicant is a corporation, one portrait photograph at least two (2) inches by two (2) inches of all officers and managing agents of said corporation and a complete set of the same officers' and agents'

fingerprints which shall be taken by the Chief of Police or his agent. If the applicant is a partnership, one front-face portrait photograph at least two (2) inches by two (2) inches in size of each partner, including a limited partner in said partnership, and a complete set of each partner or limited partner's fingerprints which shall be taken by the Chief of Police or his agents.

(i) Business, occupation, or employment of the applicant for three (3) years immediately preceding the date of application.

(j) The massage or similar business license history of the applicant; whether such person, in previously operating in this or another City or State has had a business license revoked or suspended, the reason therefor, and the business activity or occupation subsequent to such action of suspension or revocation.

(k) All criminal convictions other than misdemeanor traffic violations, including the dates of convictions, nature of the crimes and place convicted.

(l) The name and address of each massagist who is or will be employed in said establishment.

(m) Applicant must furnish a diploma or certificate of graduation from a recognized school or other institution of learning wherein the method, profession and work of massage is taught, provided, however, that if the applicant will not himself engage in the practice of massage as defined herein, he need not possess such diploma or certificate of graduation from a recognized school or other institution of learning wherein the method, profession and work of massage is taught.

(n) The name and address of any massage business or other establishment owned or operated by any person whose name is required to be given in Subsection (c) wherein the business or profession of massage is carried on.

(o) A description of any other business to be operated on the same premises or on adjoining premises owned or controlled by the applicant.

(p) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(q) Such other identification and information necessary to discover the truth of the matters hereinbefore specified as required to be set forth in the application.

(r) The names, current addresses and written statements of at least three (3) bonafide permanent residents of the Commonwealth of Massachusetts that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and last from the Commonwealth. These references must be persons other than relatives and business associates.

Upon the completion of the above provided form and the furnishing of all foregoing information the Commissioner of Health and Hospital shall accept the application for the necessary investigations. The holder of a massage establishment license shall notify the Commissioner of Health

and Hospital of each change in any of the data required to be furnished by this Section within ten (10) days after such change occurs.

SECTION 11-14. APPLICATION FOR MASSAGIST'S PERMITS.

Application for a massagist's business permit shall be made to the Commissioner of Health and Hospital in the same manner as provided above for massage establishment licenses, accompanied by the annual nonrefundable massagist's permit fee of \$75 per year or part thereof. The application shall contain but not be limited to the following:

(a) The business address and all telephone numbers where the massage is to be practiced.

(b) Name and residence address, and all names, nicknames and aliases by which the applicant has been known, including the two previous addresses immediately prior to the present address of the applicant.

(c) Social Security number, driver's license number, if any, and date of birth.

(d) Applicant's weight, height, color of hair and eyes, and sex.

(e) Written evidence that the applicant is at least eighteen (18) years of age.

(f) A complete statement of all convictions of the applicant for any felony or misdemeanor or violation of a local ordinance, except misdemeanor traffic violations.

(g) Fingerprints of the applicant taken by the Police Department.

(h) Two front-face portrait photographs taken within thirty (30) days of the date of application and at least two (2) inches by two (2) inches in size.

(i) The name and address of the recognized school attended, the dates attended and a copy of the diploma or certificate of graduation awarded the applicant showing the applicant has completed not less than seventy (70) hours of instruction. For persons presently employed as a masseur or masseuse in the City of Cambridge, this Subsection, (i), shall not apply until August 1, 1977, provided that the present employment shall be established by sworn affidavit from the employer; after which time such person must be actively engaged, enrolled, or participating in a course of study designed to fulfill the requirements of this Section and which is certified to by an official of the approved school. The burden of establishing such active engagement, enrollment or participation shall be upon the person seeking a permit herein. For persons not so employed, this Section shall be effective upon passage. In no event shall any person within the purview of this Ordinance act as aforesaid without satisfying the training requirement set forth within the City of Cambridge after August 1, 1977.

(j) The massage or similar business history and experience (10 years) prior to the date of application, including but not limited to whether or not such person in previously operating in this or another City or State under license or permit has had such license or permit denied, revoked, or suspended and the reasons therefor, and the business activities or occupations subsequent to such action of denial, suspension or revocation.

(k) The names, current addresses and written statements of at least three (3) bonafide permanent residents other than relatives, of the Commonwealth of Massachusetts that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and lastly from the Commonwealth.

(l) A medical certificate signed by a physician, licensed to practice in the Commonwealth of Massachusetts, within seven (7) days of the date of the application. The certificate shall state that the applicant was examined by the certifying physician and that the applicant is free of communicable disease. The additional information required by this Subsection shall be provided at the applicant's expense.

(m) Such other information, identification and physical examination of the person deemed necessary by the Police Chief in order to discover the truth of the matters hereinbefore required to be set forth in the application.

(n) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(o) Written declaration by the applicant, under penalty of perjury, that the foregoing information contained in the application is true and correct, said declaration being duly dated and signed in the City.

SECTION 11-15. ISSUANCE OF LICENSE OR PERMIT FOR A MASSAGE ESTABLISHMENT.

The City of Cambridge, acting by and through its Commissioner of Health and Hospital shall issue a license for a massage establishment or a permit for a masseur or masseuse if all requirements for a massage establishment or massagist permit described in this Ordinance are met unless it finds:

(a) The correct permit or license fee has not been tendered to the City, and, in the case of a check, or bank draft, honored with payment upon presentation.

(b) The operation, as proposed by the applicant, if permitted, would not comply with all applicable laws, including, but not limited to, the City's building, zoning, and health regulations.

(c) The applicant, if an individual; or any of the stockholders holding more than ten percent (10%) of the stock of the corporation, any of the officers and directors, if the applicant is a corporation; or any of the partners, including limited partners, if the applicant is a partnership; or the holder of any lien, of any nature, upon the business and/or the equipment used therein; and the manager or other person principally in charge of the operation of the business, have been convicted of any of the following offenses or convicted of an offense without the Commonwealth of Massachusetts that would have constituted any of the following offenses if committed within the Commonwealth of Massachusetts.

(1) An offense involving the use of force or violence upon the person of another that amounts to a felony.

(2) An offense involving sexual misconduct.

(3) An offense involving narcotics, dangerous drugs or dangerous

weapons that amounts to a felony.

The City of Cambridge may issue a license or permit to any person convicted of any of the crimes described in Subsection (1), (2), or (3) of this Section if it finds that such conviction occurred at least five (5) years prior to the date of the application and the applicant has had no subsequent felony convictions of any nature and no subsequent misdemeanor convictions for the crime mentioned in this Section.

(d) The applicant has knowingly made any false, misleading, or fraudulent statement of fact in the permit application or in any document required by the City in conjunction therewith.

(e) The applicant has had a massage business, masseur, or other similar permit or license denied, revoked, or suspended by the City or any other State or local agency within five (5) years prior to the date of the application.

(f) The applicant, if an individual, or any of the officers and directors, if the applicant is a corporation; or any of the partners, including limited partners, if the applicant is a partnership; and the manager or other person principally in charge of the operation of the business, is not over the age of eighteen (18) years.

SECTION 11-16. APPROVAL OR DENIAL OF APPLICATION.

The Commissioner of Health and Hospital, acting by and on behalf of the City shall act to approve or deny an application for a license or permit under this Ordinance within a reasonable period of time and in no event shall said Commisisoner act to approve or deny said license or permit later than 90 days from the date that said application was accepted by the Commissioner. Every license or permit issued pursuant to this Ordinance will terminate at the expiration of one year from the date of its issuance unless sooner suspended or revoked.

SECTION 11-17. WAIVER OF APPLICATION REQUIREMENTS.

The City of Cambridge shall waive the requirements of Section 11-10(j) and 11-14 (i) of this Ordinance if the applicant furnishes satisfactory evidence that he or she attended not less than seventy (70) hours of instruction in a school within or without this State or in any foreign country that provides education substantially equal to or in excess of the educational requirements of this Ordinance.

SECTION 11-18. MULTIPLE MASSAGE ESTABLISHMENTS.

Should any massage business have more than one location where the business of massage is pursued, then a permit, stating both the address of the principal place of business, and of the other location(s) shall be issued by the Commissioner of Health and Hospital upon the tender of a license fee of \$100. Licenses issued for other locations shall terminate on the same date as that of the principal place of business, regardless of the date of issuance.

SECTION 11-19. POSTING OF LICENSE.

(a) Every massagist shall post the permit required by this Ordinance in his work area.

(b) Every person, corporation, partnership, or association licensed under this Ordinance shall display such license in a prominent place.

SECTION 11-20. REGISTER OF EMPLOYEES.

The licensee or person designated by the licensee of a massage establishment shall maintain a register of all persons employed at any time as masseurs or masseuses and their permit numbers. Such register shall be available at the massage establishment to representatives of the City of Cambridge during regular business hours.

SECTION 11-21. REVOCATION OR SUSPENSION OF LICENSE.

Any license issued for a massage establishment may be revoked or suspended by the Commissioner of Health and Hospital, acting by and on behalf of the City, after notice and a hearing for good cause, or in any case where any of the provisions of this Ordinance are violated or where any employee of the licensee, including a masseur or masseuse is engaged in any conduct which violates any of the State or local laws or ordinances at licensee's place of business and the licensee has actual or constructive knowledge by due diligence. Such permit may also be revoked or suspended by the Commissioner after notice and hearing, upon the recommendations of any City of Cambridge health inspector that such business is being managed, conducted or maintained without regard to proper sanitation and hygiene.

SECTION 11-22. REVOCATION OF MASSEUR OR MASSEUSE PERMIT.

A masseur or masseuse permit issued by the Commissioner of Health and Hospital shall be revoked or suspended where it appears that the masseur or masseuse has been convicted of any offence which would be cause for denial of a permit upon an original application, has made a false statement on an application for a permit, or has committed an act in violation of this Ordinance.

SECTION 11-23. OPERATING REQUIREMENTS

(a) Every portion of the massage establishment, including appliances and apparatus, shall be kept clean and operating in a sanitary condition.

(b) Price rates for all services shall be prominently posted in the reception area in a location available to all prospective customers.

(c) All employees, including masseurs and masseuses, shall be clean and wear clean, nontransparent outer garments, covering the sexual and genital areas, whose use is restricted to the massage establishment. A separate dressing room for each sex must be available on the premises with individual lockers for each employee. Doors to such dressing rooms shall open inward and

shall be self-closing.

(d) All massage establishments shall be provided with clean, laundered sheets and towels in sufficient quantity and shall be laundered after each use thereof and stored in a sanitary manner.

(e) No massage establishment granted a license under the provisions of this Ordinance shall place, published or distribute cause to be placed, published or distributed any advertisement, picture, or statement which is known or through the exercise of reasonable care should be known to be false, deceptive or misleading in order to induce any person to purchase or utilize any professional massage service.

SECTION 11-24. PERSONS UNDER AGE 18 PROHIBITED ON PREMISES.

No person shall permit any person under age eighteen (18) years to come or remain on the premises of any massage business establishment, as masseur, employee, or patron, unless such person is on the premises on lawful business.

SECTION 11-25. ALCOHOLIC BEVERAGES PROHIBITED.

No person shall sell, give, dispense, provide to keep, or cause to be sold, given, dispensed, provided or kept, any alcoholic beverage on the premises of any massage business.

SECTION 11-26. HOURS.

No massage business shall be kept open for any purpose between the hours of 10:00 P.M. and 8:00 A.M.

SECTION 11-27. EMPLOYMENT OF MASSAGIST.

No person shall employ as a massagist any person unless said employee has obtained and has in effect a permit issued pursuant to this Ordinance.

SECTION 11-28. INSPECTION REQUIRED.

The Chief of Police or his authorized representatives shall from time to time make inspection of each massage business establishment for the purposes of determining that the provisions of this Ordinance are fully complied with. It shall be unlawful for any permittee to fail to allow such inspection officer access to the premises or hinder such officer in any manner.

SECTION 11-29. UNLAWFUL ACTS.

(a) It shall be unlawful for any person holding a permit under this Section to treat a person of the opposite sex, except upon signed order of a licensed physician, osteopath, chiropractor, or registered physical therapist, which order shall be dated and shall specifically state the number of treatments, not to exceed ten (10). The date and hour of each treatment given and the name of the operator shall be entered on such order by the establishment where such treatments are given and said order shall be subject to inspection by the police pursuant to Section 11-28. The requirements of this Subsection shall not apply to treatments given in the ~~xxxxxxxxxxxxxxxxxxxx~~ office of a licensed physician, osteopath or registered physical therapist, chiropractor, or in a regularly established and licensed hospital or sanitarium.

(b) It shall be unlawful for any person, in a massage parlor, to place his or her hand or hands upon, to touch with any part of his or her body, to fondle in any manner, or to massage, a sexual or genital part of any other person.

(c) It shall be unlawful for any person, in a massage parlor, to expose his or her sexual or genital parts, or any portion, thereof, to any other person. It shall also be unlawful for any person, in a massage parlor, to expose the sexual or genital parts, or any portions thereof, of any other person.

(d) It shall be unlawful for any person, while in the presence of any other person in a massage parlor, to fail to conceal with a fully opaque covering, the sexual or genital parts of his or her body.

(e) It shall be unlawful for any person owning, operating or managing a massage parlor, knowingly to cause, allow or permit in or about such massage parlor, any agent, employee, or any other person under his control or supervision to perform such acts prohibited in Subsections (a), (b) or (c) of this Section.

(f) It shall be further unlawful for any permittee under this Ordinance to administer massage on an outcall basis as defined in Section 11-10(f). Such person shall administer massage solely within an establishment licensed to carry on such business under this Ordinance. Any violation of these provisions shall be deemed grounds for revocation of the permit granted hereunder. The restriction on outcall massage shall not apply to a permittee who performs outcall massage as defined herein upon a customer or client who, because of reasons of physical defects or incapacities or due to illness is physically unable to travel to the massage establishment. If any outcall massage is performed under this exception, a record of the date and hour of each treatment, and the name and address of the customer or client, and the name of the employee administering such treatment and the type of treatment administered, as well as the nature of the physical defect, incapacity or illness of said client or customer shall be kept by the licensee or person or employee designated by the licensee. Such records shall be open to inspection by officials charged with the enforcement of public health laws. The information furnished or secured as a result of any such inspection shall be confidential. Any unauthorized disclosure or use of such information by an employee of the City of Cambridge shall be unlawful.

SECTION 11-30. SALE OR TRANSFER OR CHANGE OF LOCATION.

Upon sale, transfer or relocation of a massage establishment, the license therefor shall be null and void unless approved as provided in Section 11--15 provided, however, that upon the death or incapacity of the licensee or any co-licensee of the massage establishment, any heir or devisee of a deceased licensee, or any guardian of an heir or devisee of a deceased licensee may continue the business of the massage establishment for a reasonable period of time not to exceed sixty (60) days to allow for an orderly transfer of the license.

SECTION 11-31. NAME AND PLACE OF BUSINESS.

No person granted a license pursuant to this Ordinance shall operate the massage establishment under a name not specified in his license, nor shall he conduct business under any designation or location not specified in his license.

SECTION 11-32. TRANSFER OF LICENSE.

No license or permit shall be transferable except with the consent of the Commissioner of Health and Hospital. An application for such transfer shall be in writing and shall be accompanied by fees prescribed in Sections 11-13 and 11-14. The written application for such transfer shall contain the same information as requested herein for initial application for the license or permit.

SECTION 11-33. VIOLATION AND PENALTY.

Every person, except those persons who are specifically exempted by this Ordinance, whether acting as an individual owner, employee of the owner, operator or employee of the operator, or whether acting as a mere agent or independent contractor for the owner, employee or operator, or acting as a participant or worker in any way directly or indirectly who gives massages or operates a massage establishment of any of the services defined in this Ordinance without first obtaining a license or permit and paying a fee to do so from the City of Cambridge or shall violate any provisions of the Ordinance shall be punished by a fine not to exceed two hundred (\$200.00) dollars per violation. Each day's failure to comply with each provision of this Ordinance shall constitute a separate violation.

SECTION 11-34. SEPARABILITY.

(a) If any section, subsection, sentence, clause, phrase or portion of the Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such provision and such holding shall not affect the validity of the remaining portions thereof.

(b) All ordinances in conflict herewith are hereby repealed.

(c) This ordinance shall be in full force and effect from and after its passage, provided, however, any person, partnership, corporation or association engaged in the operation of a massage business and every person engaged in the business or profession of massage, at the time of the enactment of this ordinance shall have _____ days in which to comply with the licensing provisions of this Ordinance.

AN ORDINANCE

In amendment to an ordinance formerly entitled: "The General Ordinances of the City of Cambridge" as revised in 1972 and now designated as "The Code of the City of Cambridge."

Be it ordained by the City Council of the City of Cambridge as follows:

Chapter 11, entitled: "Health and Housing" is hereby amended by adding a new paragraph entitled: "Article III. Massage Service Regulations" which will read as follows.

ARTICLE III MASSAGE SERVICE REGULATIONS

SECTION 11-10. DEFINITIONS.

For the purpose of this ordinance, the following words and phrases shall have the meanings respectively ascribed to them by this section.

(a) Employees. Any person over eighteen (18) years of age, other than a massagist, who renders any service in connection with the operation of a massage business and receives compensation from the operator of the business or patrons.

(b) Licensee. The person to whom a license has been issued to own or operate a massage establishment as defined herein.

(c) Massage. Any method of pressure on or friction against, or stroking, kneading, rubbing, tapping, pounding, vibrating, or stimulating of the external parts of the human body with the hands or with the aid of any mechanical electrical apparatus or appliances with or without such supplementary aids as rubbing alcohol, liniments, antiseptics, oils, powder, creams, lotions, ointment or other such similar preparations commonly used in the practice of massage, under such circumstances that it is reasonably expected that the person to whom the treatment is provided or some third person on his or her behalf will pay money or give any other consideration or any gratuity therefor.

(d) Massage Establishment. Any establishment having a source of income or compensation derived from the practice of massage as defined in Subsection (c), and which has a fixed place of business where any person, firm, association or corporation engages in or carries on any of the activities as defined in Subsection (c).

(e) Massagist, Masseur or Masseuse. Any person who, for any consideration whatsoever, engages in the practice of massage as defined in Subsection (c).

(f) Outcall Massage Service. Any business, the function of which is to engage in or carry on massages at a location designated by the customer or client rather than at a massage establishment as defined in Subsection (c).

(g) Patron. Any person over eighteen (18) years of age who receives a massage under such circumstances that it is reasonably expected that he or she will pay money or give any other consideration therefor.

(h) Permittee. The person to whom a permit has been issued to act in the capacity of a massagist (masseur or masseuse) as herein defined.

(i) Person. Any individual, partnership, firm, association, joint stock company, corporation or combination of individuals of whatever form or character.

(j) Recognized School. Any school or educational institution licensed to do business as a school or educational institution in the State in which it is located, or any school recognized by or approved by or affiliated with the American Massage and Therapy Association, Inc., and which has for its purpose the teaching of the theory, method, profession, or work of massage, which school requires a resident course of study not less than seventy (70) hours before the student shall be furnished with a diploma or certificate of graduation from such school or institution of learning following the successful completion of such course of study or learning.

(k) Sexual or Genital Area. Genitals, pubic area, buttocks, anus, or perineum of any person, or the vulva or breasts of a female.

SECTION 11-11. PERMIT REQUIRED.

(a) Business license required. No person shall engage in or carry out the business of massage unless he has a valid massage business license issued by the City pursuant to the provisions of this ordinance for each and every separate office or place of business conducted by such person.

(b) Massagist's permit required. No person shall practice massage as a massagist, employee or otherwise, unless he has a valid and subsisting massagist's permit issued to him by the City pursuant to the provisions of this ordinance.

SECTION 11-12. EXEMPTIONS.

This ordinance shall not apply to the following individuals while engaged in the personal performance of the duties or their respective professions:

(a) Physicians, surgeons, chiropractors, osteopaths, or physical therapists who are duly licensed to practice their respective professions in the Commonwealth of Massachusetts.

(b) Nurses who are registered under the laws of the Commonwealth of Massachusetts.

(c) Barbers and beauticians who are duly licensed under the laws of the Commonwealth of Massachusetts, except that this exemption shall

apply solely to the massaging of the neck, face, scalp and hair of the customer or client for cosmetic or beautifying purposes.

- (g) Copy of identification such as driver's license and social security card.
- (h) One portrait photograph of the applicant at least two (2) inches by two (2) inches and a complete set of applicant's fingerprints which shall be taken by the Chief of Police or his agent. If the applicant is a corporation, one portrait photograph at least two (2) inches by two (2) inches of all officers and managing agents of said corporation and a complete set of the same officers' and agents'

fingerprints which shall be taken by the Chief of Police or his agent. If the applicant is a partnership, one front-face portrait photograph at least two (2) inches by two (2) inches in size of each partner, including a limited partner in said partnership, and a complete set of each partner or limited partner's fingerprints which shall be taken by the Chief of Police or his agents.

(i) Business, occupation, or employment of the applicant for three (3) years immediately preceding the date of application.

(j) The massage or similar business license history of the applicant; whether such person, in previously operating in this or another City or State has had a business license revoked or suspended, the reason therefor, and the business activity or occupation subsequent to such action of suspension or revocation.

(k) All criminal convictions other than misdemeanor traffic violations, including the dates of convictions, nature of the crimes and place convicted.

(l) The name and address of each massagist who is or will be employed in said establishment.

(m) Applicant must furnish a diploma or certificate of graduation from a recognized school or other institution of learning wherein the method, profession and work of massage is taught, provided, however, that if the applicant will not himself engage in the practice of massage as defined herein, he need not possess such diploma or certificate of graduation from a recognized school or other institution of learning wherein the method, profession and work of massage is taught.

(n) The name and address of any massage business or other establishment owned or operated by any person whose name is required to be given in Subsection (c) wherein the business or profession of massage is carried on.

(o) A description of any other business to be operated on the same premises or on adjoining premises owned or controlled by the applicant.

(p) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(q) Such other identification and information necessary to discover the truth of the matters hereinbefore specified as required to be set forth in the application.

(r) The names, current addresses and written statements of at least three (3) bonafide permanent residents of the Commonwealth of Massachusetts that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and last from the Commonwealth. These references must be persons other than relatives and business associates.

Upon the completion of the above provided form and the furnishing of all foregoing information the Commissioner of Health and Hospital shall accept the application for the necessary investigations. The holder of a massage establishment license shall notify the Commissioner of Health

and Hospital of each change in any of the data required to be furnished by this Section within ten (10) days after such change occurs.

SECTION 11-14. APPLICATION FOR MASSAGIST'S PERMITS.

Application for a massagist's business permit shall be made to the Commissioner of Health and Hospital in the same manner as provided above for massage establishment licenses, accompanied by the annual nonrefundable massagist's permit fee of \$75 per year or part thereof. The application shall contain but not be limited to the following:

(a) The business address and all telephone numbers where the massage is to be practiced.

(b) Name and residence address, and all names, nicknames and aliases by which the applicant has been known, including the two previous addresses immediately prior to the present address of the applicant.

(c) Social Security number, driver's license number, if any, and date of birth.

(d) Applicant's weight, height, color of hair and eyes, and sex.

(e) Written evidence that the applicant is at least eighteen (18) years of age.

(f) A complete statement of all convictions of the applicant for any felony or misdemeanor or violation of a local ordinance, except misdemeanor traffic violations.

(g) Fingerprints of the applicant taken by the Police Department.

(h) Two front-face portrait photographs taken within thirty (30) days of the date of application and at least two (2) inches by two (2) inches in size.

(i) The name and address of the recognized school attended, the dates attended and a copy of the diploma or certificate of graduation awarded the applicant showing the applicant has completed not less than seventy (70) hours of instruction. For persons presently employed as a masseur or masseuse in the City of Cambridge, this Subsection, (i), shall not apply until August 1, 1977, provided that the present employment shall be established by sworn affidavit from the employer; after which time such person must be actively engaged, enrolled, or participating in a course of study designed to fulfill the requirements of this Section and which is certified to by an official of the approved school. The burden of establishing such active engagement, enrollment or participation shall be upon the person seeking a permit herein. For persons not so employed, this Section shall be effective upon passage. In no event shall any person within the purview of this Ordinance act as aforesaid without satisfying the training requirement set forth within the City of Cambridge after August 1, 1977.

(j) The massage or similar business history and experience (10 years) prior to the date of application, including but not limited to whether or not such person in previously operating in this or another City or State under license or permit has had such license or permit denied, revoked, or suspended and the reasons therefor, and the business activities or occupations subsequent to such action of denial, suspension or revocation.

(k) The names, current addresses and written statements of at least three (3) bonafide permanent residents other than relatives, of the Commonwealth of Massachusetts that the applicant is of good moral character. If the applicant is able, the statement must first be furnished from residents of the City, then the County, and lastly from the Commonwealth.

(l) A medical certificate signed by a physician, licensed to practice in the Commonwealth of Massachusetts, within seven (7) days of the date of the application. The certificate shall state that the applicant was examined by the certifying physician and that the applicant is free of communicable disease. The additional information required by this Subsection shall be provided at the applicant's expense.

(m) Such other information, identification and physical examination of the person deemed necessary by the Police Chief in order to discover the truth of the matters hereinbefore required to be set forth in the application.

(n) Authorization for the City, its agents and employees to seek information and conduct an investigation into the truth of the statements set forth in the application and the qualifications of the applicant for the permit.

(o) Written declaration by the applicant, under penalty of perjury, that the foregoing information contained in the application is true and correct, said declaration being duly dated and signed in the City.

SECTION 11-15. ISSUANCE OF LICENSE OR PERMIT FOR A MASSAGE ESTABLISHMENT.

The City of Cambridge, acting by and through its Commissioner of Health and Hospital shall issue a license for a massage establishment or a permit for a masseur or masseuse, if all requirements for a massage establishment or massagist permit described in this Ordinance are met unless it finds:

(a) The correct permit or license fee has not been tendered to the City, and, in the case of a check, or bank draft, honored with payment upon presentation.

(b) The operation, as proposed by the applicant, if permitted, would not comply with all applicable laws, including, but not limited to, the City's building, zoning, and health regulations.

(c) The applicant, if an individual; or any of the stockholders holding more than ten percent (10%) of the stock of the corporation, any of the officers and directors, if the applicant is a corporation; or any of the partners, including limited partners, if the applicant is a partnership; or the holder of any lien, of any nature, upon the business and/or the equipment used therein; and the manager or other person principally in charge of the operation of the business, have been convicted of any of the following offenses or convicted of an offense without the Commonwealth of Massachusetts that would have constituted any of the following offenses if committed within the Commonwealth of Massachusetts.

(1) An offense involving the use of force or violence upon the person of another that amounts to a felony.

(2) An offense involving sexual misconduct.

(3) An offense involving narcotics, dangerous drugs or dangerous

weapons that amounts to a felony.

The City of Cambridge may issue a license or permit to any person convicted of any of the crimes described in Subsection (1), (2), or (3) of this Section if it finds that such conviction occurred at least five (5) years prior to the date of the application and the applicant has had no subsequent felony convictions of any nature and no subsequent misdemeanor convictions for the crime mentioned in this Section.

(d) The applicant has knowingly made any false, misleading, or fraudulent statement of fact in the permit application or in any document required by the City in conjunction therewith.

(e) The applicant has had a massage business, masseur, or other similar permit or license denied, revoked, or suspended by the City or any other State or local agency within five (5) years prior to the date of the application.

(f) The applicant, if an individual, or any of the officers and directors, if the applicant is a corporation; or any of the partners, including limited partners, if the applicant is a partnership; and the manager or other person principally in charge of the operation of the business, is not over the age of eighteen (18) years.

SECTION 11-16. APPROVAL OR DENIAL OF APPLICATION.

The Commissioner of Health and Hospital, acting by and on behalf of the City shall act to approve or deny an application for a license or permit under this Ordinance within a reasonable period of time and in no event shall said Commissioner act to approve or deny said license or permit later than 90 days from the date that said application was accepted by the Commissioner. Every license or permit issued pursuant to this Ordinance will terminate at the expiration of one year from the date of its issuance unless sooner suspended or revoked.

SECTION. 11-17. WAIVER OF APPLICATION REQUIREMENTS.

The City of Cambridge shall waive the requirements of Section 11-10(j) and 11-14 (i) of this Ordinance if the applicant furnishes satisfactory evidence that he or she attended not less than seventy (70) hours of instruction in a school within or without this State or in any foreign country that provides education substantially equal to or in excess of the educational requirements of this Ordinance.

SECTION 11-18. MULTIPLE MASSAGE ESTABLISHMENTS.

Should any massage business have more than one location where the business of massage is pursued, then a permit, stating both the address of the principal place of business, and of the other location(s) shall be issued by the Commissioner of Health and Hospital upon the tender of a license fee of \$100. Licenses issued for other locations shall terminate on the same date as that of the principal place of business, regardless of the date of issuance.

SECTION 11-19. POSTING OF LICENSE.

(a) Every massagist shall post the permit required by this Ordinance in his work area.

(b) Every person, corporation, partnership, or association licensed under this Ordinance shall display such license in a prominent place.

SECTION 11-20. REGISTER OF EMPLOYEES.

The licensee or person designated by the licensee of a massage establishment shall maintain a register of all persons employed at any time as masseurs or masseuses and their permit numbers. Such register shall be available at the massage establishment to representatives of the City of Cambridge during regular business hours.

SECTION 11-21. REVOCATION OR SUSPENSION OF LICENSE.

Any license issued for a massage establishment may be revoked or suspended by the Commissioner of Health and Hospital, acting by and on behalf of the City, after notice and a hearing for good cause, or in any case where any of the provisions of this Ordinance are violated or where any employee of the licensee, including a masseur or masseuse is engaged in any conduct which violates any of the State or local laws or ordinances at licensee's place of business and the licensee has actual or constructive knowledge by due diligence. Such permit may also be revoked or suspended by the Commissioner after notice and hearing, upon the recommendations of any City of Cambridge health inspector that such business is being managed, conducted or maintained without regard to proper sanitation and hygiene.

SECTION 11-22. REVOCATION OF MASSEUR OR MASSEUSE PERMIT.

A masseur or masseuse permit issued by the Commissioner of Health and Hospital shall be revoked or suspended where it appears that the masseur or masseuse has been convicted of any offense which would be cause for denial of a permit upon an original application, has made a false statement on an application for a permit, or has committed an act in violation of this Ordinance.

SECTION 11-23. OPERATING REQUIREMENTS

(a) Every portion of the massage establishment, including appliances and apparatus, shall be kept clean and operating in a sanitary condition.

(b) Price rates for all services shall be prominently posted in the reception area in a location available to all prospective customers.

(c) All employees, including masseurs and masseuses, shall be clean and wear clean, nontransparent outer garments, covering the sexual and genital areas, whose use is restricted to the massage establishment. A separate dressing room for each sex must be available on the premises with individual lockers for each employee. Doors to such dressing rooms shall open inward and

shall be self-closing.

(d) All massage establishments shall be provided with clean, laundered sheets and towels in sufficient quantity and shall be laundered after each use thereof and stored in a sanitary manner.

(e) No massage establishment granted a license under the provisions of this Ordinance shall place, published or distribute cause to be placed, published or distributed any advertisement, picture, or statement which is known or through the exercise of reasonable care should be known to be false, deceptive or misleading in order to induce any person to purchase or utilize any professional massage service.

SECTION 11-24. PERSONS UNDER AGE 18 PROHIBITED ON PREMISES.

No person shall permit any person under age eighteen (18) years to come or remain on the premises of any massage business establishment, as masseur, employee, or patron, unless such person is on the premises on lawful business.

SECTION 11-25. ALCOHOLIC BEVERAGES PROHIBITED.

No person shall sell, give, dispense, provide to keep, or cause to be sold, given, dispensed, provided or kept, any alcoholic beverage on the premises of any massage business.

SECTION 11-26. HOURS.

No massage business shall be kept open for any purpose between the hours of 10:00 P.M. and 8:00 A.M.

SECTION 11-27. EMPLOYMENT OF MASSAGIST.

No person shall employ as a massagist any person unless said employee has obtained and has in effect a permit issued pursuant to this Ordinance.

SECTION 11-28. INSPECTION REQUIRED.

The Chief of Police or his authorized representatives shall from time to time make inspection of each massage business establishment for the purposes of determining that the provisions of this Ordinance are fully complied with. It shall be unlawful for any permittee to fail to allow such inspection officer access to the premises or hinder such officer in any manner.

SECTION 11-29. UNLAWFUL ACTS.

(a) It shall be unlawful for any person holding a permit under this Section to treat a person of the opposite sex, except upon signed order of a licensed physician, osteopath, chiropractor, or registered physical therapist, which order shall be dated and shall specifically state the number of treatments, not to exceed ten (10). The date and hour of each treatment given and the name of the operator shall be entered on such order by the establishment where such treatments are given and said order shall be subject to inspection by the police pursuant to Section 11-28. The requirements of this Subsection shall not apply to treatments given in the ~~xxxxxxxxxxxxxxxxxxxxxxxx~~ office of a licensed physician, osteopath or registered physical therapist, chiropractor, or in a regularly established and licensed hospital or sanitarium.

(b) It shall be unlawful for any person, in a massage parlor, to place his or her hand or hands upon, to touch with any part of his or her body, to fondle in any manner, or to massage, a sexual or genital part of any other person.

(c) It shall be unlawful for any person, in a massage parlor, to expose his or her sexual or genital parts, or any portion, thereof, to any other person. It shall also be unlawful for any person, in a massage parlor, to expose the sexual or genital parts, or any portions thereof, of any other person.

(d) It shall be unlawful for any person, while in the presence of any other person in a massage parlor, to fail to conceal with a fully opaque covering, the sexual or genital parts of his or her body.

(e) It shall be unlawful for any person owning, operating or managing a massage parlor, knowingly to cause, allow or permit in or about such massage parlor, any agent, employee, or any other person under his control or supervision to perform such acts prohibited in Subsections (a), (b) or (c) of this Section.

(f) It shall be further unlawful for any permittee under this Ordinance to administer massage on an outcall basis as defined in Section 11-10(f). Such person shall administer massage solely within an establishment licensed to carry on such business under this Ordinance. Any violation of these provisions shall be deemed grounds for revocation of the permit granted hereunder. The restriction on outcall massage shall not apply to a permittee who performs outcall massage as defined herein upon a customer or client who, because of reasons of physical defects or incapacities or due to illness is physically unable to travel to the massage establishment. If any outcall massage is performed under this exception, a record of the date and hour of each treatment, and the name and address of the customer or client, and the name of the employee administering such treatment and the type of treatment administered, as well as the nature of the physical defect, incapacity or illness of said client or customer shall be kept by the licensee or person or employee designated by the licensee. Such records shall be open to inspection by officials charged with the enforcement of public health laws. The information furnished or secured as a result of any such inspection shall be confidential. Any unauthorized disclosure or use of such information by an employee of the City of Cambridge shall be unlawful.

SECTION 11-30. SALE OR TRANSFER OR CHANGE OF LOCATION.

Upon sale, transfer or relocation of a massage establishment, the license therefor shall be null and void unless approved as provided in Section 11--15 provided, however, that upon the death or incapacity of the licensee or any co-licensee of the massage establishment, any heir or devisee of a deceased licensee, or any guardian of an heir or devisee of a deceased licensee may continue the business of the massage establishment for a reasonable period of time not to exceed sixty (60) days to allow for an orderly transfer of the license.

SECTION 11-31. NAME AND PLACE OF BUSINESS.

No person granted a license pursuant to this Ordinance shall operate the massage establishment under a name not specified in his license, nor shall he conduct business under any designation or location not specified in his license.

SECTION 11-32. TRANSFER OF LICENSE.

No license or permit shall be transferable except with the consent of the Commissioner of Health and Hospital. An application for such transfer shall be in writing and shall be accompanied by fees prescribed in Sections 11-13 and 11-14. The written application for such transfer shall contain the same information as requested herein for initial application for the license or permit.

SECTION 11-33. VIOLATION AND PENALTY.

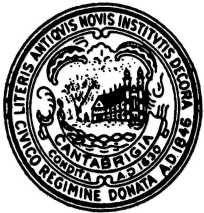
Every person, except those persons who are specifically exempted by this Ordinance, whether acting as an individual owner, employee of the owner, operator or employee of the operator, or whether acting as a mere agent or independent contractor for the owner, employee or operator, or acting as a participant or worker in any way directly or indirectly who gives massages or operates a massage establishment of any of the services defined in this Ordinance without first obtaining a license or permit and paying a fee to do so from the City of Cambridge or shall violate any provisions of the Ordinance shall be punished by a fine not to exceed two hundred (\$200.00) dollars per violation. Each day's failure to comply with each provision of this Ordinance shall constitute a separate violation.

SECTION 11-34. SEPARABILITY.

(a) If any section, subsection, sentence, clause, phrase or portion of the Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such provision and such holding shall not affect the validity of the remaining portions thereof.

(b) All ordinances in conflict herewith are hereby repealed.

(c) This ordinance shall be in full force and effect from and after its passage, provided, however, any person, partnership, corporation or association engaged in the operation of a massage business and every person engaged in the business or profession of massage, at the time of the enactment of this ordinance shall have _____ days in which to comply with the licensing provisions of this Ordinance.


