*Offered By Councillor PENTIA*

*Be it resolved,*

THAT THE MEDFORD CITY COUNCIL IN BEHALF OF THE MEDFORD RATE PAYERS OF THE MWRA WATER AND SEWER ASSESSMENTS PUBLICLY CHASTISE THE TOTAL WRECKLESS DISREGARD AND INSENSITIVITY TO MWRA FOR ITS LACK OF PROFESSIONAL MANAGEMENT PERCEPTION IN ITS MOST RECENT UNCONTROLLED, UNAUTHORIZED, AND WITHOUT JUSTIFICATION OF MORE THAN \$1,000,000. IN PAY RAISES TO MWRA PERSONNEL.

BE IT FURTHER RESOLVED, THAT IN LIGHT OF THE FACT THAT MUNICIPALITIES AND TOWNSHIPS HAVE HAD TO MAKE MOST DRASTIC BUDGETARY CUTS NOT ONLY ELIMINATING PAY RAISES BUT ALSO ELIMINATING JOBS, THAT OUR CITY OF MEDFORD PUBLICLY ADDRESS THROUGH THIS OFFICIAL RESOLUTION, OUR MASSACHUSETTS GENERAL COURT AND SISTER CITIES AND TOWNS OF THE MWRA THAT THEY BE SUPPORTIVE OF THE AT PRESENT LEGISLATION FILE OF ELIMINATING THE WRECKLESS, WITHOUT CONTROL, AUTONOMOUS AUTHORITY OF THE MWRA.
