OFFICIAL ANNOUNCEMENT

It gives me great pleasure to announce the organization of the Cambridge City Council Committees for the years 1978 and 1979. It is my belief that each Councillor be given the opportunity to put his/her special area of expertise to use in committee work. It is my hope that the present City Council will work together to reach a common goal that brings service to the community.

I have established a new committee of Human Services. This committee will analyze the overall planning and coordination of programs and the delivery of services of related agencies operating within the city.

In order to avoid overlapping of committees and hearings and to assure adequate supportive staffing, I am asking that the chairperson for each committee choose a day of the week for the committee to meet on.

I am enclosing a list of committee staff assignments which were made during the past council term. These assignments were made for the purpose of ensuring continuity of services to each committee by dealing directly with the particular staff person assigned.

I would recommend that these assignments remain in effect unless you feel strongly that they be different. The only change, of course, will be the addition of the Committee on Human Services.

I wish to call to your attention the Rules of the City Council. These Rules will be followed with the cooperation of all Councillors. In particular, I wish to call to your attention Rule 20.

I have instructed my Administrative Assistant to meet weekly with the City Clerk, the Deputy City Clerk and the Administrative Assistant to the City Council. It is my hope that as a result of these meetings City Council business will be conducted in a more efficient manner.
